

Problems

Algebra

A1. Let $(a_n)_{n\geqslant 1}$ be a sequence of positive real numbers with the property that

$$(a_{n+1})^2 + a_n a_{n+2} \leqslant a_n + a_{n+2}$$

for all positive integers n. Show that $a_{2022} \leq 1$.

(Nigeria)

A2. Let $k \ge 2$ be an integer. Find the smallest integer $n \ge k + 1$ with the property that there exists a set of n distinct real numbers such that each of its elements can be written as a sum of k other distinct elements of the set.

(Slovakia)

A3. Let $\mathbb{R}_{>0}$ be the set of positive real numbers. Find all functions $f: \mathbb{R}_{>0} \to \mathbb{R}_{>0}$ such that, for every $x \in \mathbb{R}_{>0}$, there exists a unique $y \in \mathbb{R}_{>0}$ satisfying

$$xf(y) + yf(x) \le 2.$$

(Netherlands)

A4. Let $n \ge 3$ be an integer, and let $x_1, x_2, ..., x_n$ be real numbers in the interval [0, 1]. Let $s = x_1 + x_2 + ... + x_n$, and assume that $s \ge 3$. Prove that there exist integers i and j with $1 \le i < j \le n$ such that

$$2^{j-i}x_ix_j > 2^{s-3}.$$

(Trinidad and Tobago)

A5. Find all positive integers $n \ge 2$ for which there exist n real numbers $a_1 < \cdots < a_n$ and a real number r > 0 such that the $\frac{1}{2}n(n-1)$ differences $a_j - a_i$ for $1 \le i < j \le n$ are equal, in some order, to the numbers $r^1, r^2, \ldots, r^{\frac{1}{2}n(n-1)}$.

(Czech Republic)

A6. Let \mathbb{R} be the set of real numbers. We denote by \mathcal{F} the set of all functions $f: \mathbb{R} \to \mathbb{R}$ such that

$$f(x + f(y)) = f(x) + f(y)$$

for every $x, y \in \mathbb{R}$. Find all rational numbers q such that for every function $f \in \mathcal{F}$, there exists some $z \in \mathbb{R}$ satisfying f(z) = qz.

(Indonesia)

A7. For a positive integer n we denote by s(n) the sum of the digits of n. Let $P(x) = x^n + a_{n-1}x^{n-1} + \cdots + a_1x + a_0$ be a polynomial, where $n \ge 2$ and a_i is a positive integer for all $0 \le i \le n-1$. Could it be the case that, for all positive integers k, s(k) and s(P(k)) have the same parity?

(Belarus)

A8. For a positive integer n, an n-sequence is a sequence (a_0, \ldots, a_n) of non-negative integers satisfying the following condition: if i and j are non-negative integers with $i + j \leq n$, then $a_i + a_j \leq n$ and $a_{a_i + a_j} = a_{i+j}$.

Let f(n) be the number of *n*-sequences. Prove that there exist positive real numbers c_1 , c_2 and λ such that

$$c_1 \lambda^n < f(n) < c_2 \lambda^n$$

for all positive integers n.

(Canada)

Combinatorics

C1. A ± 1 -sequence is a sequence of 2022 numbers a_1, \ldots, a_{2022} , each equal to either +1 or -1. Determine the largest C so that, for any ± 1 -sequence, there exists an integer k and indices $1 \le t_1 < \ldots < t_k \le 2022$ so that $t_{i+1} - t_i \le 2$ for all i, and

$$\left| \sum_{i=1}^{k} a_{t_i} \right| \geqslant C.$$

(Czech Republic)

C2. The Bank of Oslo issues coins made out of two types of metal: aluminium (denoted A) and copper (denoted C). Morgane has n aluminium coins, and n copper coins, and arranges her 2n coins in a row in some arbitrary initial order. Given a fixed positive integer $k \leq 2n$, she repeatedly performs the following operation: identify the largest subsequence containing the k-th coin from the left which consists of consecutive coins made of the same metal, and move all coins in that subsequence to the left end of the row. For example, if n = 4 and k = 4, the process starting from the configuration AACCCACA would be

$$AACCCACA \rightarrow CCCAAACA \rightarrow AAACCCCA \rightarrow CCCCAAAA \rightarrow \cdots$$

Find all pairs (n, k) with $1 \le k \le 2n$ such that for every initial configuration, at some point of the process there will be at most one aluminium coin adjacent to a copper coin.

(France)

- In each square of a garden shaped like a 2022×2022 board, there is initially a tree of height 0. A gardener and a lumberjack alternate turns playing the following game, with the gardener taking the first turn:
 - The gardener chooses a square in the garden. Each tree on that square and all the surrounding squares (of which there are at most eight) then becomes one unit taller.
 - The lumberjack then chooses four different squares on the board. Each tree of positive height on those squares then becomes one unit shorter.

We say that a tree is majestic if its height is at least 10^6 . Determine the largest number K such that the gardener can ensure there are eventually K majestic trees on the board, no matter how the lumberjack plays.

(Colombia)

C4.

Let n > 3 be a positive integer. Suppose that n children are arranged in a circle, and n coins are distributed between them (some children may have no coins). At every step, a child with at least 2 coins may give 1 coin to each of their immediate neighbours on the right and left. Determine all initial distributions of coins from which it is possible that, after a finite number of steps, each child has exactly one coin.

(Israel)

C5. Let $m, n \ge 2$ be integers, let X be a set with n elements, and let X_1, X_2, \ldots, X_m be pairwise distinct non-empty, not necessary disjoint subsets of X. A function $f: X \to \{1, 2, \ldots, n+1\}$ is called *nice* if there exists an index k such that

$$\sum_{x \in X_k} f(x) > \sum_{x \in X_i} f(x) \text{ for all } i \neq k.$$

Prove that the number of nice functions is at least n^n .

(Germany)

Let n be a positive integer. We start with n piles of pebbles, each initially containing a single pebble. One can perform moves of the following form: choose two piles, take an equal number of pebbles from each pile and form a new pile out of these pebbles. For each positive integer n, find the smallest number of non-empty piles that one can obtain by performing a finite sequence of moves of this form.

(Croatia)

Lucy starts by writing s integer-valued 2022-tuples on a blackboard. After doing that, she can take any two (not necessarily distinct) tuples $\mathbf{v} = (v_1, \dots, v_{2022})$ and $\mathbf{w} = (w_1, \dots, w_{2022})$ that she has already written, and apply one of the following operations to obtain a new tuple:

$$\mathbf{v} + \mathbf{w} = (v_1 + w_1, \dots, v_{2022} + w_{2022})$$

 $\mathbf{v} \vee \mathbf{w} = (\max(v_1, w_1), \dots, \max(v_{2022}, w_{2022}))$

and then write this tuple on the blackboard.

It turns out that, in this way, Lucy can write any integer-valued 2022-tuple on the blackboard after finitely many steps. What is the smallest possible number s of tuples that she initially wrote?

(Czech Republic)

C8.

Alice fills the fields of an $n \times n$ board with numbers from 1 to n^2 , each number being used exactly once. She then counts the total number of good paths on the board. A good path is a sequence of fields of arbitrary length (including 1) such that:

- (i) The first field in the sequence is one that is only adjacent to fields with larger numbers,
- (ii) Each subsequent field in the sequence is adjacent to the previous field,
- (iii) The numbers written on the fields in the sequence are in increasing order.

Two fields are considered adjacent if they share a common side. Find the smallest possible number of good paths Alice can obtain, as a function of n.

(Serbia)

Let $\mathbb{Z}_{\geq 0}$ be the set of non-negative integers, and let $f: \mathbb{Z}_{\geq 0} \times \mathbb{Z}_{\geq 0} \to \mathbb{Z}_{\geq 0}$ be a bijection such that whenever $f(x_1, y_1) > f(x_2, y_2)$, we have $f(x_1 + 1, y_1) > f(x_2 + 1, y_2)$ and $f(x_1, y_1 + 1) > f(x_2, y_2 + 1)$.

Let N be the number of pairs of integers (x, y), with $0 \le x, y < 100$, such that f(x, y) is odd. Find the smallest and largest possible value of N.

(U.S.A.)

Geometry

G1. Let ABCDE be a convex pentagon such that BC = DE. Assume there is a point T inside ABCDE with TB = TD, TC = TE and $\angle TBA = \angle AET$. Let lines CD and CT intersect line AB at points P and Q, respectively, and let lines CD and DT intersect line AE at points R and S, respectively. Assume that points P, A, A, A and A, A, A respectively, are collinear and occur on their lines in this order. Prove that the points A, A, A are concyclic.

G2. In the acute-angled triangle ABC, the point F is the foot of the altitude from A, and P is a point on the segment AF. The lines through P parallel to AC and AB meet BC at D and E, respectively. Points $X \neq A$ and $Y \neq A$ lie on the circles ABD and ACE, respectively, such that DA = DX and EA = EY.

Prove that B, C, X and Y are concyclic.

(Netherlands)

Let ABCD be a cyclic quadrilateral. Assume that the points Q, A, B, P are collinear in this order, in such a way that the line AC is tangent to the circle ADQ, and the line BD is tangent to the circle BCP. Let M and N be the midpoints of BC and AD, respectively. Prove that the following three lines are concurrent: line CD, the tangent of circle ANQ at point A, and the tangent to circle BMP at point B.

(Slovakia)

Let ABC be an acute-angled triangle with AC > AB, let O be its circumcentre, and let D be a point on the segment BC. The line through D perpendicular to BC intersects the lines AO, AC and AB at W, X and Y, respectively. The circumcircles of triangles AXY and ABC intersect again at $Z \neq A$.

Prove that if OW = OD, then DZ is tangent to the circle AXY.

(United Kingdom)

G5. Let ABC be a triangle, and let ℓ_1 and ℓ_2 be two parallel lines. For i = 1, 2, let ℓ_i meet the lines BC, CA, and AB at X_i , Y_i , and Z_i , respectively. Suppose that the line through X_i perpendicular to BC, the line through Y_i perpendicular to CA, and finally the line through Z_i perpendicular to AB, determine a non-degenerate triangle Δ_i .

Show that the circumcircles of Δ_1 and Δ_2 are tangent to each other.

(Vietnam)

In an acute-angled triangle ABC, point H is the foot of the altitude from A. Let P be a moving point such that the bisectors k and ℓ of angles PBC and PCB, respectively, intersect each other on the line segment AH. Let k and AC meet at E, let ℓ and AB meet at F, and let EF and AH meet at Q. Prove that, as P varies, the line PQ passes through a fixed point.

(Iran)

G7. Let ABC and A'B'C' be two triangles having the same circumcircle ω , and the same orthocentre H. Let Ω be the circumcircle of the triangle determined by the lines AA', BB' and CC'. Prove that H, the centre of ω , and the centre of Ω are collinear.

(Denmark)

Let AA'BCC'B' be a convex cyclic hexagon such that AC is tangent to the incircle of the triangle A'B'C', and A'C' is tangent to the incircle of the triangle ABC. Let the lines AB and A'B' meet at X and let the lines BC and B'C' meet at Y.

Prove that if XBYB' is a convex quadrilateral, then it has an incircle.

(Australia)

Number Theory

N1. A number is called *Norwegian* if it has three distinct positive divisors whose sum is equal to 2022. Determine the smallest Norwegian number.

(Note: The total number of positive divisors of a Norwegian number is allowed to be larger than 3.)

(Cyprus)

(N2.)

Find all positive integers n > 2 such that

$$n! \left| \prod_{\substack{p < q \le n, \\ p, q \text{ primes}}} (p+q). \right|$$

(Nigeria)

N3. Let a > 1 be a positive integer, and let d > 1 be a positive integer coprime to a. Let $x_1 = 1$ and, for $k \ge 1$, define

$$x_{k+1} = \begin{cases} x_k + d & \text{if } a \text{ doesn't divide } x_k, \\ x_k/a & \text{if } a \text{ divides } x_k. \end{cases}$$

Find the greatest positive integer n for which there exists an index k such that x_k is divisible by a^n .

(Croatia)

N4.

Find all triples of positive integers (a, b, p) with p prime and

$$a^p = b! + p.$$

(Belgium)

N5. For each $1 \le i \le 9$ and $T \in \mathbb{N}$, define $d_i(T)$ to be the total number of times the digit i appears when all the multiples of 1829 between 1 and T inclusive are written out in base 10.

Show that there are infinitely many $T \in \mathbb{N}$ such that there are precisely two distinct values among $d_1(T), d_2(T), \ldots, d_9(T)$.

 $(\mathit{United}\ \mathit{Kingdom})$

N6. Let Q be a set of prime numbers, not necessarily finite. For a positive integer n consider its prime factorisation; define p(n) to be the sum of all the exponents and q(n) to be the sum of the exponents corresponding only to primes in Q. A positive integer n is called special if p(n) + p(n+1) and q(n) + q(n+1) are both even integers. Prove that there is a constant c > 0 independent of the set Q such that for any positive integer N > 100, the number of special integers in [1, N] is at least cN.

(For example, if $Q = \{3, 7\}$, then p(42) = 3, q(42) = 2, p(63) = 3, q(63) = 3, p(2022) = 3, q(2022) = 1.)

(Costa Rica)

N7. Let k be a positive integer and let S be a finite set of odd prime numbers. Prove that there is at most one way (modulo rotation and reflection) to place the elements of S around a circle such that the product of any two neighbors is of the form $x^2 + x + k$ for some positive integer x.

(U.S.A.)

<u>N8.</u>

Prove that $5^n - 3^n$ is not divisible by $2^n + 65$ for any positive integer n.

(Belgium)

Solutions

Algebra

(A1.) Let $(a_n)_{n\geqslant 1}$ be a sequence of positive real numbers with the property that

$$(a_{n+1})^2 + a_n a_{n+2} \le a_n + a_{n+2}$$

for all positive integers n. Show that $a_{2022} \leq 1$.

(Nigeria)

Solution. We begin by observing that $(a_{n+1})^2 - 1 \le a_n + a_{n+2} - a_n a_{n+2} - 1$, which is equivalent to

$$(a_{n+1})^2 - 1 \le (1 - a_n)(a_{n+2} - 1).$$

Suppose now that there exists a positive integer n such that $a_{n+1} > 1$ and $a_{n+2} > 1$. Since $(a_{n+1})^2 - 1 \le (1 - a_n)(a_{n+2} - 1)$, we deduce that $0 < 1 - a_n < 1 < 1 + a_{n+2}$, thus $(a_{n+1})^2 - 1 < (a_{n+2} + 1)(a_{n+2} - 1) = (a_{n+2})^2 - 1$.

On the other hand, $(a_{n+2})^2 - 1 \le (1 - a_{n+3})(a_{n+1} - 1) < (1 + a_{n+1})(a_{n+1} - 1) = (a_{n+1})^2 - 1$, a contradiction. We have shown that we cannot have two consecutive terms, except maybe a_1 and a_2 , strictly greater than 1.

Finally, suppose $a_{2022} > 1$. This implies that $a_{2021} \le 1$ and $a_{2023} \le 1$. Therefore $0 < (a_{2022})^2 - 1 \le (1 - a_{2021})(a_{2023} - 1) \le 0$, a contradiction. We conclude that $a_{2022} \le 1$.

A2. Let $k \ge 2$ be an integer. Find the smallest integer $n \ge k + 1$ with the property that there exists a set of n distinct real numbers such that each of its elements can be written as a sum of k other distinct elements of the set.

(Slovakia)

Answer: n = k + 4.

Solution. First we show that $n \ge k + 4$. Suppose that there exists such a set with n numbers and denote them by $a_1 < a_2 < \cdots < a_n$.

Note that in order to express a_1 as a sum of k distinct elements of the set, we must have $a_1 \ge a_2 + \cdots + a_{k+1}$ and, similarly for a_n , we must have $a_{n-k} + \cdots + a_{n-1} \ge a_n$. We also know that $n \ge k+1$.

If n = k + 1 then we have $a_1 \ge a_2 + \cdots + a_{k+1} > a_1 + \cdots + a_k \ge a_{k+1}$, which gives a contradiction.

If n = k + 2 then we have $a_1 \ge a_2 + \cdots + a_{k+1} \ge a_{k+2}$, that again gives a contradiction.

If n = k + 3 then we have $a_1 \ge a_2 + \cdots + a_{k+1}$ and $a_3 + \cdots + a_{k+2} \ge a_{k+3}$. Adding the two inequalities we get $a_1 + a_{k+2} \ge a_2 + a_{k+3}$, again a contradiction.

It remains to give an example of a set with k+4 elements satisfying the condition of the problem. We start with the case when k=2l and $l \ge 1$. In that case, denote by $A_i = \{-i,i\}$ and take the set $A_1 \cup \cdots \cup A_{l+2}$, which has exactly k+4=2l+4 elements. We are left to show that this set satisfies the required condition.

Note that if a number i can be expressed in the desired way, then so can -i by negating the expression. Therefore, we consider only $1 \le i \le l+2$.

If i < l + 2, we sum the numbers from some l - 1 sets A_j with $j \neq 1, i + 1$, and the numbers i + 1 and -1.

For i = l + 2, we sum the numbers from some l - 1 sets A_j with $j \neq 1, l + 1$, and the numbers l + 1 and 1.

It remains to a give a construction for odd k = 2l + 1 with $l \ge 1$ (since $k \ge 2$). To that end, we modify the construction for k = 2l by adding 0 to the previous set.

This is a valid set as 0 can be added to each constructed expression, and 0 can be expressed as follows: take the numbers 1, 2, -3 and all the numbers from the remaining l-1 sets A_4, A_5, \dots, A_{l+2} .

A3. Let $\mathbb{R}_{>0}$ be the set of positive real numbers. Find all functions $f: \mathbb{R}_{>0} \to \mathbb{R}_{>0}$ such that, for every $x \in \mathbb{R}_{>0}$, there exists a unique $y \in \mathbb{R}_{>0}$ satisfying

$$xf(y) + yf(x) \le 2.$$

(Netherlands)

Answer: The function f(x) = 1/x is the only solution.

Solution 1. First we prove that the function f(x) = 1/x satisfies the condition of the problem statement. The AM-GM inequality gives

$$\frac{x}{y} + \frac{y}{x} \geqslant 2$$

for every x, y > 0, with equality if and only if x = y. This means that, for every x > 0, there exists a unique y > 0 such that

$$\frac{x}{y} + \frac{y}{x} \leqslant 2,$$

namely y = x.

Let now $f: \mathbb{R}_{>0} \to \mathbb{R}_{>0}$ be a function that satisfies the condition of the problem statement. We say that a pair of positive real numbers (x, y) is good if $xf(y) + yf(x) \leq 2$. Observe that if (x, y) is good, then so is (y, x).

Lemma 1.0. If (x, y) is good, then x = y.

Proof. Assume that there exist positive real numbers $x \neq y$ such that (x, y) is good. The uniqueness assumption says that y is the unique positive real number such that (x, y) is good. In particular, (x, x) is not a good pair. This means that

$$x f(x) + x f(x) > 2$$

and thus xf(x) > 1. Similarly, (y, x) is a good pair, so (y, y) is not a good pair, which implies yf(y) > 1. We apply the AM-GM inequality to obtain

$$xf(y) + yf(x) \ge 2\sqrt{xf(y) \cdot yf(x)} = 2\sqrt{xf(x) \cdot yf(y)} > 2.$$

This is a contradiction, since (x, y) is a good pair.

By assumption, for any x > 0, there always exists a good pair containing x, however Lemma 1 implies that the only good pair that can contain x is (x, x), so

$$xf(x) \leqslant 1 \iff f(x) \leqslant \frac{1}{x},$$

for every x > 0.

In particular, with x = 1/f(t) for t > 0, we obtain

$$\frac{1}{f(t)} \cdot f\left(\frac{1}{f(t)}\right) \leqslant 1.$$

Hence

$$t \cdot f\left(\frac{1}{f(t)}\right) \leqslant t f(t) \leqslant 1.$$

We claim that (t, 1/f(t)) is a good pair for every t > 0. Indeed,

$$t \cdot f\left(\frac{1}{f(t)}\right) + \frac{1}{f(t)}f(t) = t \cdot f\left(\frac{1}{f(t)}\right) + 1 \leqslant 2.$$

Lemma 1 implies that $t = 1/f(t) \iff f(t) = 1/t$ for every t > 0.

Solution 1.1. We give an alternative way to prove that f(x) = 1/x assuming $f(x) \le 1/x$ for every x > 0.

Indeed, if f(x) < 1/x then for every a > 0 with f(x) < 1/a < 1/x (and there are at least two of them), we have

$$af(x) + xf(a) < 1 + \frac{x}{a} < 2.$$

Hence (x, a) is a good pair for every such a, a contradiction. We conclude that f(x) = 1/x.

Solution 1.2. We can also conclude from Lemma 1 and $f(x) \le 1/x$ as follows.

Lemma 2. The function f is decreasing.

Proof. Let y > x > 0. Lemma 1 says that (x, y) is not a good pair, but (y, y) is. Hence

$$xf(y) + yf(x) > 2 \geqslant 2yf(y) > yf(y) + xf(y),$$

where we used y > x (and f(y) > 0) in the last inequality. This implies that f(x) > f(y), showing that f is decreasing.

We now prove that f(x) = 1/x for all x. Fix a value of x and note that for y > x we must have xf(x) + yf(x) > xf(y) + yf(x) > 2 (using that f is decreasing for the first step), hence $f(x) > \frac{2}{x+y}$. The last inequality is true for every y > x > 0. If we fix x and look for the supremum of the expression $\frac{2}{x+y}$ over all y > x, we get

$$f(x) \geqslant \frac{2}{x+x} = \frac{1}{x}.$$

Since we already know that $f(x) \leq 1/x$, we conclude that f(x) = 1/x.

Solution 2.0. As in the first solution, we note that f(x) = 1/x is a solution, and we set out to prove that it is the only one. We write g(x) for the unique positive real number such that (x, g(x)) is a good pair. In this solution, we prove Lemma 2 without assuming Lemma 1.

Lemma 2. The function f is decreasing.

Proof. Consider x < y. It holds that $yf(g(y)) + g(y)f(y) \le 2$. Moreover, because y is the only positive real number such that (g(y), y) is a good pair and $x \ne y$, we have xf(g(y)) + g(y)f(x) > 2. Combining these two inequalities yields

$$xf(g(y)) + g(y)f(x) > 2 \ge yf(g(y)) + g(y)f(y),$$

or f(g(y))(x-y) > g(y)(f(y)-f(x)). Because g(y) and f(g(y)) are both positive while x-y is negative, it follows that f(y) < f(x), showing that f is decreasing.

We now prove Lemma 1 using Lemma 2. Suppose that $x \neq y$ but $xf(y) + yf(x) \leq 2$. As in the first solution, we get xf(x) + xf(x) > 2 and yf(y) + yf(y) > 2, which implies xf(x) + yf(y) > 2. Now

$$xf(x) + yf(y) > 2 \geqslant xf(y) + yf(x)$$

implies (x - y)(f(x) - f(y)) > 0, which contradicts the fact that f is decreasing. So y = x is the unique y such that (x, y) is a good pair, and in particular we have $f(x) \le 1/x$.

We can now conclude the proof as in any of the Solutions 1.x.

Solution 3.0. As in the other solutions we verify that the function f(x) = 1/x is a solution. We first want to prove the following lemma:

Lemma 3. For all $x \in \mathbb{R}_{>0}$ we actually have xf(g(x)) + g(x)f(x) = 2 (that is: the inequality is actually an equality).

Proof. We proceed by contradiction: Assume there exists some number x > 0 such that for y = g(x) we have xf(y) + yf(x) < 2. Then for any $0 < \epsilon < \frac{2 - xf(y) - yf(x)}{2f(x)}$ we have, by uniqueness of y, that $xf(y+\epsilon) + (y+\epsilon)f(x) > 2$. Therefore

$$f(y+\epsilon) > \frac{2 - (y+\epsilon)f(x)}{x} = \frac{2 - yf(x) - \epsilon f(x)}{x}$$

$$> \frac{2 - yf(x) - \frac{2 - xf(y) - yf(x)}{2}}{x}$$

$$= \frac{2 - xf(y) - yf(x)}{2x} + f(y) > f(y). \tag{1}$$

Furthermore, for every such ϵ we have $g(y+\epsilon)f(y+\epsilon)+(y+\epsilon)f(g(y+\epsilon)) \leq 2$ and $g(y+\epsilon)f(y)+yf(g(y+\epsilon))>2$ (since $y\neq y+\epsilon=g(g(y+\epsilon))$). This gives us the two inequalities

$$f(g(y+\epsilon)) \le \frac{2-g(y+\epsilon)f(y+\epsilon)}{y+\epsilon}$$
 and $f(g(y+\epsilon)) > \frac{2-g(y+\epsilon)f(y)}{y}$.

Combining these two inequalities and rearranging the terms leads to the inequality

$$2\epsilon < g(y+\epsilon)[(y+\epsilon)f(y) - yf(y+\epsilon)].$$

Moreover combining with the inequality (1) we obtain

$$2\epsilon < g(y+\epsilon)\left[(y+\epsilon)f(y) - y\left(\frac{2-xf(y)-yf(x)}{2x} + f(y)\right)\right] = g(y+\epsilon)\left[\epsilon f(y) - y\frac{2-xf(y)-yf(x)}{2x}\right].$$

We now reach the desired contradiction, since for ϵ sufficiently small we have that the left hand side is positive while the right hand side is negative.

With this lemma it then follows that for all $x, y \in \mathbb{R}_{>0}$ we have

$$xf(y) + yf(x) \geqslant 2$$
,

since for y = g(x) we have equality and by uniqueness for $y \neq g(x)$ the inequality is strict.

In particular for every $x \in \mathbb{R}_{>0}$ and for y = x we have $2xf(x) \ge 2$, or equivalently $f(x) \ge 1/x$ for all $x \in \mathbb{R}_{>0}$. With this inequality we obtain for all $x \in \mathbb{R}_{>0}$

$$2 \geqslant x f(g(x)) + g(x) f(x) \geqslant \frac{x}{g(x)} + \frac{g(x)}{x} \geqslant 2,$$

where the first inequality comes from the problem statement. Consequently each of these inequalities must actually be an equality, and in particular we obtain f(x) = 1/x for all $x \in \mathbb{R}_{>0}$.

Solution 4. Again, let us prove that f(x) = 1/x is the only solution. Let again g(x) be the unique positive real number such that (x, g(x)) is a good pair.

Lemma 4. The function f is strictly convex.

Proof. Consider the function $q_s(x) = f(x) + sx$ for some real number s. If f is not strictly convex, then there exist u < v and $t \in (0,1)$ such that

$$f(tu + (1-t)v) \ge tf(u) + (1-t)f(v).$$

Hence

$$q_s(tu + (1-t)v) \ge tf(u) + (1-t)f(v) + s(tu + (1-t)v)$$

= $tq_s(u) + (1-t)q_s(v)$.

Let w = tu + (1-t)v and consider the case s = f(g(w))/g(w). For that particular choice of s, the function $q_s(x)$ has a unique minimum at x = w. However, since $q_s(w) \ge tq_s(u) + (1-t)q_s(v)$, it must hold $q_s(u) \le q_s(w)$ or $q_s(v) \le q_s(w)$, a contradiction.

Lemma 5. The function f is continuous.

Proof. Since f is strictly convex and defined on an open interval, it is also continuous.

As in Solution 1, we can prove that $f(x) \le 1/x$. If f(x) < 1/x, then we consider the function h(y) = xf(y) + yf(x) which is continuous. Since h(x) < 2, there exist at least two distinct $z \ne x$ such that h(z) < 2 giving that (x, z) is good pair for both values of z, a contradiction. We conclude that f(x) = 1/x as desired.

Comment. Lemma 5 implies Lemma 3, using an argument similar as in the end of Solution 4.

A4. Let $n \ge 3$ be an integer, and let $x_1, x_2, ..., x_n$ be real numbers in the interval [0, 1]. Let $s = x_1 + x_2 + ... + x_n$, and assume that $s \ge 3$. Prove that there exist integers i and j with $1 \le i < j \le n$ such that

$$2^{j-i}x_ix_i > 2^{s-3}$$
.

(Trinidad and Tobago)

Solution.

Let $1 \le a < b \le n$ be such that $2^{b-a}x_ax_b$ is maximal. This choice of a and b implies that $x_{a+t} \le 2^tx_a$ for all $1-a \le t \le b-a-1$, and similarly $x_{b-t} \le 2^tx_b$ for all $b-n \le t \le b-a+1$. Now, suppose that $x_a \in \left(\frac{1}{2^{u+1}}, \frac{1}{2^u}\right]$ and $x_b \in \left(\frac{1}{2^{v+1}}, \frac{1}{2^v}\right]$, and write $x_a = 2^{-\alpha}$, $x_b = 2^{-\beta}$. Then

$$\sum_{i=1}^{a+u-1} x_i \le 2^u x_a \left(\frac{1}{2} + \frac{1}{4} + \ldots + \frac{1}{2^{a+u-1}} \right) < 2^u x_a \le 1,$$

and similarly,

$$\sum_{i=b-v+1}^{n} x_i \leqslant 2^v x_b \left(\frac{1}{2} + \frac{1}{4} + \dots + \frac{1}{2^{n-b+v}} \right) < 2^v x_b \leqslant 1,$$

In other words, the sum of the x_i 's for i outside of the interval [a+u,b-v] is strictly less than 2. Since the total sum is at least 3, and each term is at most 1, it follows that this interval must have at least two integers. i.e., a+u < b-v. Thus, by bounding the sum of the x_i for $i \in [1, a+u] \cup [b-v, n]$ like above, and trivially bounding each $x_i \in (a+u, b-v)$ by 1, we obtain

$$s < 2^{u+1}x_a + 2^{v+1}x_b + ((b-v) - (a+u) - 1) = b - a + (2^{u+1-\alpha} + 2^{v+1-\beta} - (u+v+1)).$$

Now recall $\alpha \in (u, u + 1]$ and $\beta \in (v, v + 1]$, so applying Bernoulli's inequality yields

$$2^{u+1-\alpha} + 2^{v+1-\beta} - u - v - 1 \le (1 + (u+1-\alpha))) + (1 + (v+1-\beta)) - u - v - 1 = 3 - \alpha - \beta.$$

It follows that $s - 3 < b - a - \alpha - \beta$, and so

$$2^{s-3} < 2^{b-a-\alpha-\beta} = 2^{b-a} x_a x_b.$$

Comment 1. It is not hard to see that the inequality is tight. Suppose that n=2k+1, and we set $x_{k+1}=1, x_k=x_{k+2}=\frac{1}{2}+\frac{1}{2^k}$, and $x_{k+1-t}=x_{k+1+t}=\frac{1}{2^t}$. Then s=3 (so the right hand side is 1), and

$$\max_{i < j} 2^{j-i} x_i x_j = 2^2 \left(\frac{1}{2} + \frac{1}{2^k} \right)^2,$$

which can be made arbitrarily close to 1. Note that s can be made larger by putting in more 1-s in the middle (and this accommodates even n as well).

Comment 2. An alternative formulation of the problem is to show that there exists a positive constant c (or find the best such c) such that

$$\max_{i < j} 2^{j-i} x_i x_j > c 2^s.$$

The above shows that c = 1/8 is the best possible. A somewhat simpler ending to the proof can be given for c = 1/32.

End of solution for c = 1/32.

As in the original solution, we arrive at

$$s < 2^{u+1}x_a + 2^{v+1}x_b + ((b-v) - (a+u) - 1) = b - a + (2^{u+1-\alpha} + 2^{v+1-\beta} - (u+v+1)).$$

Now $2^{b-a}x_ax_b \ge 2^{b-a}2^{-u-1}2^{-v-1}$, so it is enough to show s-5 < b-a-u-v-2, or s < b-a-u-v+3. The fact that $u+1-\alpha < 1$ and $v+1-\beta < 1$ implies $2^{u+1-\alpha}+2^{v+1-\beta} < 4$, and so s < b-a+(2+2-u-v-1)=b-a-u-v-3.

A5. Find all positive integers $n \ge 2$ for which there exist n real numbers $a_1 < \cdots < a_n$ and a real number r > 0 such that the $\frac{1}{2}n(n-1)$ differences $a_j - a_i$ for $1 \le i < j \le n$ are equal, in some order, to the numbers $r^1, r^2, \ldots, r^{\frac{1}{2}n(n-1)}$.

(Czech Republic)

Answer: $n \in \{2, 3, 4\}.$

Solution. We first show a solution for each $n \in \{2, 3, 4\}$. We will later show the impossibility of finding such a solution for $n \ge 5$.

For n = 2, take for example $(a_1, a_2) = (1, 3)$ and r = 2.

For n = 3, take the root r > 1 of $x^2 - x - 1 = 0$ (the golden ratio) and set $(a_1, a_2, a_3) = (0, r, r + r^2)$. Then

$$(a_2 - a_1, a_3 - a_2, a_3 - a_1) = (r, r^2, r + r^2 = r^3).$$

For n = 4, take the root $r \in (1, 2)$ of $x^3 - x - 1 = 0$ (such a root exists because $1^3 - 1 - 1 < 0$ and $2^3 - 2 - 1 > 0$) and set $(a_1, a_2, a_3, a_4) = (0, r, r + r^2, r + r^2 + r^3)$. Then

$$(a_2 - a_1, a_3 - a_2, a_4 - a_3, a_3 - a_1, a_4 - a_2, a_4 - a_1) = (r, r^2, r^3, r^4, r^5, r^6).$$

For $n \ge 5$, we will proceed by contradiction. Suppose there exist numbers $a_1 < \cdots < a_n$ and r > 1 satisfying the conditions of the problem. We start with a lemma:

Lemma. We have $r^{n-1} > 2$.

Proof. There are only n-1 differences a_j-a_i with j=i+1, so there exists an exponent $e \le n$ and a difference a_j-a_i with $j \ge i+2$ such that $a_j-a_i=r^e$. This implies

$$r^n \geqslant r^e = a_j - a_i = (a_j - a_{j-1}) + (a_{j-1} - a_i) > r + r = 2r$$

thus $r^{n-1} > 2$ as desired.

To illustrate the general approach, we first briefly sketch the idea behind the argument in the special case n = 5. In this case, we clearly have $a_5 - a_1 = r^{10}$. Note that there are 3 ways to rewrite $a_5 - a_1$ as a sum of two differences, namely

$$(a_5 - a_4) + (a_4 - a_1), (a_5 - a_3) + (a_3 - a_1), (a_5 - a_2) + (a_2 - a_1).$$

Using the lemma above and convexity of the function $f(n) = r^n$, we argue that those three ways must be $r^{10} = r^9 + r^1 = r^8 + r^4 = r^7 + r^6$. That is, the "large" exponents keep dropping by 1, while the "small" exponents keep increasing by n-2, n-3, ..., 2. Comparing any two such equations, we then get a contradiction unless $n \leq 4$.

Now we go back to the full proof for any $n \ge 5$. Denote $b = \frac{1}{2}n(n-1)$. Clearly, we have $a_n - a_1 = r^b$. Consider the n-2 equations of the form:

$$a_n - a_1 = (a_n - a_i) + (a_i - a_1)$$
 for $i \in \{2, \dots, n-1\}$.

In each equation, one of the two terms on the right-hand side must be at least $\frac{1}{2}(a_n-a_1)$. But from the lemma we have $r^{b-(n-1)}=r^b/r^{n-1}<\frac{1}{2}(a_n-a_1)$, so there are at most n-2 sufficiently large elements in $\{r^k\mid 1\leqslant k< b\}$, namely $r^{b-1},\ldots,r^{b-(n-2)}$ (note that r^b is already used for a_n-a_1). Thus, the "large" terms must be, in some order, precisely equal to elements in

$$L = \{r^{b-1}, \dots, r^{b-(n-2)}\}.$$

Next we claim that the "small" terms in the n-2 equations must be equal to the elements in

$$S = \{ r^{b - (n-2) - \frac{1}{2}i(i+1)} \mid 1 \le i \le n - 2 \},\$$

in the corresponding order (the largest "large" term with the smallest "small" term, etc.). Indeed, suppose that

$$r^b = a_n - a_1 = r^{b-i} + r^{\alpha_i} \text{ for } i \in \{1, \dots, n-2\},$$

where $1 \le \alpha_1 < \cdots < \alpha_{n-2} \le b - (n-1)$. Since r > 1 and $f(r) = r^n$ is convex, we have

$$r^{b-1} - r^{b-2} > r^{b-2} - r^{b-3} > \ldots > r^{b-(n-3)} - r^{b-(n-2)}$$

implying

$$r^{\alpha_2} - r^{\alpha_1} > r^{\alpha_3} - r^{\alpha_2} > \ldots > r^{\alpha_{n-2}} - r^{\alpha_{n-3}}$$

Convexity of $f(r) = r^n$ further implies

$$\alpha_2 - \alpha_1 > \alpha_3 - \alpha_2 > \ldots > \alpha_{n-2} - \alpha_{n-3}.$$

Note that $\alpha_{n-2} - \alpha_{n-3} \ge 2$: Otherwise we would have $\alpha_{n-2} - \alpha_{n-3} = 1$ and thus

$$r^{\alpha_{n-3}} \cdot (r-1) = r^{\alpha_{n-2}} - r^{\alpha_{n-3}} = r^{b-(n-3)} - r^{b-(n-2)} = r^{b-(n-2)} \cdot (r-1),$$

implying that $\alpha_{n-3} = b - (n-2)$, a contradiction. Therefore, we have

$$\alpha_{n-2} - \alpha_1 = (\alpha_{n-2} - \alpha_{n-3}) + \dots + (\alpha_2 - \alpha_1)$$

$$\geq 2 + 3 + \dots + (n-2)$$

$$= \frac{1}{2}(n-2)(n-1) - 1 = \frac{1}{2}n(n-3).$$

On the other hand, from $\alpha_{n-2} \leq b - (n-1)$ and $\alpha_1 \geq 1$ we get

$$\alpha_{n-2} - \alpha_1 \le b - n = \frac{1}{2}n(n-1) - n = \frac{1}{2}n(n-3),$$

implying that equalities must occur everywhere and the claim about the small terms follows. Now, assuming $n-2 \ge 2$, we have the two different equations:

$$r^{b} = r^{b-(n-2)} + r^{b-(n-2)-1}$$
 and $r^{b} = r^{b-(n-3)} + r^{b-(n-2)-3}$,

which can be rewritten as

$$r^{n-1} = r+1$$
 and $r^{n+1} = r^4 + 1$. (1)

Simple algebra now gives

$$r^4 + 1 = r^{n+1} = r^{n-1} \cdot r^2 = r^3 + r^2 \implies (r-1)(r^3 - r - 1) = 0.$$

Since $r \neq 1$, using Equation (1) we conclude $r^3 = r + 1 = r^{n-1}$, thus n = 4, which gives a contradiction.

A6. Let \mathbb{R} be the set of real numbers. We denote by \mathcal{F} the set of all functions $f: \mathbb{R} \to \mathbb{R}$ such that

$$f(x + f(y)) = f(x) + f(y)$$

for every $x, y \in \mathbb{R}$. Find all rational numbers q such that for every function $f \in \mathcal{F}$, there exists some $z \in \mathbb{R}$ satisfying f(z) = qz.

(Indonesia)

Answer: The desired set of rational numbers is $\left\{\frac{n+1}{n}: n \in \mathbb{Z}, n \neq 0\right\}$.

Solution. Let Z be the set of all rational numbers q such that for every function $f \in \mathcal{F}$, there exists some $z \in \mathbb{R}$ satisfying f(z) = qz. Let further

$$S = \left\{ \frac{n+1}{n} : n \in \mathbb{Z}, n \neq 0 \right\}.$$

We prove that Z = S by showing the two inclusions: $S \subseteq Z$ and $Z \subseteq S$.

We first prove that $S \subseteq Z$. Let $f \in \mathcal{F}$ and let P(x,y) be the relation f(x+f(y)) = f(x) + f(y). First note that P(0,0) gives f(f(0)) = 2f(0). Then, P(0,f(0)) gives f(2f(0)) = 3f(0). We claim that

$$f(kf(0)) = (k+1)f(0)$$

for every integer $k \ge 1$. The claim can be proved by induction. The cases k = 1 and k = 2 have already been established. Assume that f(kf(0)) = (k+1)f(0) and consider P(0, kf(0)) which gives

$$f((k+1)f(0)) = f(0) + f(kf(0)) = (k+2)f(0).$$

This proves the claim. We conclude that $\frac{k+1}{k} \in \mathbb{Z}$ for every integer $k \ge 1$. Note that P(-f(0), 0) gives f(-f(0)) = 0. We now claim that

$$f(-kf(0)) = (-k+1)f(0)$$

for every integer $k \ge 1$. The proof by induction is similar to the one above. We conclude that $\frac{-k+1}{-k} \in \mathbb{Z}$ for every integer $k \ge 1$. This shows that $S \subseteq \mathbb{Z}$.

We now prove that $Z \subseteq S$. Let p be a rational number outside the set S. We want to prove that p does not belong to Z. To that end, we construct a function $f \in \mathcal{F}$ such that $f(z) \neq pz$ for every $z \in \mathbb{R}$. The strategy is to first construct a function

$$g \colon [0,1) \to \mathbb{Z}$$

and then define f as $f(x) = g(\lbrace x \rbrace) + \lfloor x \rfloor$. This function f belongs to \mathcal{F} . Indeed,

$$f(x + f(y)) = g(\{x + f(y)\}) + [x + f(y)]$$

$$= g(\{x + g(\{y\}) + [y]\}) + [x + g(\{y\}) + [y]]$$

$$= g(\{x\}) + [x] + g(\{y\}) + [y]$$

$$= f(x) + f(y),$$

where we used that q only takes integer values.

Lemma 1. For every $\alpha \in [0,1)$, there exists $m \in \mathbb{Z}$ such that

$$m + n \neq p(\alpha + n)$$

for every $n \in \mathbb{Z}$.

Proof. Note that if p=1 the claim is trivial. If $p \neq 1$, then the claim is equivalent to the existence of an integer m such that

$$\frac{m-p\alpha}{p-1}$$

is never an integer. Assume the contrary. That would mean that both

$$\frac{m-p\alpha}{p-1}$$
 and $\frac{(m+1)-p\alpha}{p-1}$

are integers, and so is their difference. The latter is equal to

$$\frac{1}{p-1}$$
.

Since we assumed $p \notin S$, 1/(p-1) is never an integer. This is a contradiction.

Define $g: [0,1) \to \mathbb{Z}$ by $g(\alpha) = m$ for any integer m that satisfies the conclusion of Lemma 1. Note that $f(z) \neq pz$ if and and only if

$$g(\{z\}) + |z| \neq p(\{z\} + |z|)$$

The latter is guaranteed by the construction of the function g. We conclude that $p \notin Z$ as desired. This shows that $Z \subset S$.

A7. For a positive integer n we denote by s(n) the sum of the digits of n. Let $P(x) = x^n + a_{n-1}x^{n-1} + \cdots + a_1x + a_0$ be a polynomial, where $n \ge 2$ and a_i is a positive integer for all $0 \le i \le n-1$. Could it be the case that, for all positive integers k, s(k) and s(P(k)) have the same parity?

(Belarus)

Answer: No. For any such polynomial there exists a positive integer k such that s(k) and s(P(k)) have different parities.

Solution. With the notation above, we begin by choosing a positive integer t such that

$$10^{t} > \max \left\{ \frac{100^{n-1}a_{n-1}}{(10^{\frac{1}{n-1}} - 9^{\frac{1}{n-1}})^{n-1}}, \frac{a_{n-1}}{9} 10^{n-1}, \frac{a_{n-1}}{9} (10a_{n-1})^{n-1}, \dots, \frac{a_{n-1}}{9} (10a_{0})^{n-1} \right\}.$$

As a direct consequence of 10^t being bigger than the first quantity listed in the above set, we get that the interval

$$I = \left[\left(\frac{9}{a_{n-1}} 10^t \right)^{\frac{1}{n-1}}, \left(\frac{1}{a_{n-1}} 10^{t+1} \right)^{\frac{1}{n-1}} \right)$$

contains at least 100 consecutive positive integers.

Let X be a positive integer in I such that X is congruent to 1 mod 100. Since $X \in I$ we have

$$9 \cdot 10^t \leqslant a_{n-1} X^{n-1} < 10^{t+1},$$

thus the first digit (from the left) of $a_{n-1}X^{n-1}$ must be 9.

Next, we observe that $a_{n-1}(10a_i)^{n-1} < 9 \cdot 10^t \le a_{n-1}X^{n-1}$, thus $10a_i < X$ for all i, which immediately implies that $a_0 < a_1X < \cdots < a_nX^n$, and the number of digits of this strictly increasing sequence forms a strictly increasing sequence too. In other words, if i < j, the number of digits of a_iX^i is less than the number of digits of a_iX^j .

Let α be the number of digits of $a_{n-1}X^{n-1}$, thus $10^{\alpha-1} \leqslant a_{n-1}X^{n-1} < 10^{\alpha}$. We are now going to look at $P(10^{\alpha}X)$ and $P(10^{\alpha-1}X)$ and prove that the sum of their digits has different parities. This will finish the proof since $s(10^{\alpha}X) = s(10^{\alpha-1}X) = s(X)$.

We have $P(10^{\alpha}X) = 10^{\alpha n}X^n + a_{n-1}10^{\alpha(n-1)}X^{n-1} + \cdots + a_0$, and since $10^{\alpha(i+1)} > 10^{\alpha i}a_{n-1}X^{n-1} > 10^{\alpha i}a_iX^i$, the terms $a_i10^{\alpha i}X^i$ do not interact when added; in particular, there is no carryover caused by addition. Thus we have $s(P(10^{\alpha}X)) = s(X^n) + s(a_{n-1}X^{n-1}) + \cdots + s(a_0)$. We now look at $P(10^{\alpha-1}X) = 10^{(\alpha-1)n}X^n + a_{n-1}10^{(\alpha-1)(n-1)}X^{n-1} + \cdots + a_0$. Firstly, if

We now look at $P(10^{\alpha-1}X) = 10^{(\alpha-1)n}X^n + a_{n-1}10^{(\alpha-1)(n-1)}X^{n-1} + \cdots + a_0$. Firstly, if i < n-1, then $a_{n-1}X^{n-1}$ has more digits than a_iX^i and $a_{n-1}X^{n-1} \ge 10a_iX^i$. It now follows that $10^{(\alpha-1)(i+1)+1} > 10^{(\alpha-1)i}a_{n-1}X^{n-1} \ge 10^{(\alpha-1)i+1}a_iX^i$, thus all terms $10^{(\alpha-1)i}a_iX^i$ for $0 \le i \le n-1$ come in 'blocks', exactly as in the previous case.

Finally, $10^{(\alpha-1)n+1} > 10^{(\alpha-1)(n-1)} a_{n-1} X^{n-1} > 10^{(\alpha-1)n}$, thus $10^{(\alpha-1)(n-1)} a_{n-1} X^{n-1}$ has exactly $(\alpha-1)n+1$ digits, and its first digit is 9, as established above. On the other hand, $10^{(\alpha-1)n} X^n$ has exactly $(\alpha-1)n$ zeros, followed by 01 (as X is 1 mod 100). Therefore, when we add the terms, the 9 and 1 turn into 0, the 0 turns into 1, and nothing else is affected.

Putting everything together, we obtain

$$s(P(10^{\alpha-1}X)) = s(X^n) + s(a_{n-1}X^{n-1}) + \dots + s(a_0) - 9 = s(P(10^{\alpha}X)) - 9,$$

thus $s(P(10^{\alpha}X))$ and $s(P(10^{\alpha-1}X))$ have different parities, as claimed.

A8. For a positive integer n, an n-sequence is a sequence (a_0, \ldots, a_n) of non-negative integers satisfying the following condition: if i and j are non-negative integers with $i + j \leq n$, then $a_i + a_j \leq n$ and $a_{a_i + a_j} = a_{i+j}$.

Let f(n) be the number of n-sequences. Prove that there exist positive real numbers c_1 , c_2 and λ such that

$$c_1 \lambda^n < f(n) < c_2 \lambda^n$$

for all positive integers n.

(Canada)

Answer: Such constants exist with $\lambda = 3^{1/6}$; we will discuss appropriate values of c_1 and c_2 in the solution below.

Solution. In order to solve this, we will give a complete classification of n-sequences.

Let $k = \lfloor n/2 \rfloor$. We will say that an *n*-sequence is *large* if $a_i > k$ for some *i*, and *small* if no such *i* exists. For now we will assume that (a_i) is not the identity sequence (in other words, that $a_i \neq i$ for some *i*).

Lemma 1. If $a_r = a_s$ and r, s < n, then $a_{r+1} = a_{s+1}$.

Proof. We have $a_{r+1} = a_{a_r+a_1} = a_{a_s+a_1} = a_{s+1}$.

Lemma 2. If $i \leq k$, then $a_i \leq k$.

Proof. We have $i + i \le n$, so $a_i + a_i \le n$ whence $a_i \le k$.

Lemma 3. There exist r, s such that $a_r = a_s$ and $r \neq s$.

Proof. If $a_0 \neq 0$ then $a_{2a_0} = a_0$. Otherwise, $a_{a_i} = a_i$ for all i, so take i such that $a_i \neq i$ (which we can do by our earlier assumption).

Lemma 4. Let r be the smallest index such that $a_s = a_r$ for some s > r, and let d be the minimum positive integer such that $a_{r+d} = a_r$. Then

- 1. The subsequence $(a_r, a_{r+1}, \ldots, a_n)$ is periodic with minimal period d. That is, for u < v, we have $a_u = a_v$ if and only if $u, v \ge r$ and $d \mid v u$.
- 2. $a_i = i$ for i < r and $a_i \ge r$ for $i \ge r$.

In this case we say (a_i) has period d and offset r.

Proof. We prove each in turn:

- 1. The "if" implication is clear from Lemma 1. For the reverse direction, suppose $a_u = a_v$. Then there are integers $r \leq u_0, v_0 < r + d$ such that $d \mid u u_0, v v_0$, so $a_{u_0} = a_u = a_v = a_{v_0}$. If $u_0 < v_0$ then $a_{r+d+u_0-v_0} = a_{r+d} = a_r$, contradicting the minimality of d. There is a similar contradiction when $u_0 > v_0$. Thus $u_0 = v_0$, so $d \mid u v$.
- 2. If r = 0 there is nothing to prove. Otherwise $a_0 = a_{2a_0}$ so $2a_0 = 0$. Then we have $a_{a_i} = a_i$ for all i, so $a_i = i$ for i < r.

Lemma 5. Either

- 1. $d \mid a_i i$ for all i, or
- 2. r = 0 and $d \mid a_i i d/2$ for all *i*.

Proof. Note that Lemma 4 tells us that if $a_u = a_v$ then $d \mid u - v$. Since $a_{a_i + a_0} = a_i$ for all i, we have $d \mid a_i - i + a_0$. For i = 0, this means that $d \mid 2a_0$. If $d \mid a_0$ then that means that $d \mid a_i - i$ for all i. Otherwise, if $d \nmid a_0$, then $d \mid a_0 - d/2$ and thus $d \mid a_i - i - d/2$ for all i. In addition, part 2 of Lemma 4 says that we must have r = 0 in this case.

Lemma 6. If d is even and $d \mid a_0 - d/2$, then (a_i) is small. (Note that we must have r = 0 in this case.)

Proof. Note that if $d \leq k+1$, then by Lemma 2, (a_0, \ldots, a_{d-1}) is a period for the sequence consisting of elements at most k, so (a_i) must be small. Now suppose d > k+1. We show that $a_i \leq k$ for all i by induction. Note that Lemma 2 already establishes this for $i \leq k$. We must have $d \mid a_{d/2}$ and $a_{d/2} \leq k < d$ so $a_{d/2} = 0$. Thus, for i > k, if $a_j \leq k$ for j < i, then $a_{i-d/2} \leq k$, so $a_i = a_{(i-d/2)+d/2} = a_{a_{i-d/2}} \leq k$.

Lemma 7. If (a_i) is small, then $r + d \leq k + 1$.

Proof. Since (a_i) is small, there exists $u, v \le k+1$ such that u < v and $a_u = a_v$. Thus $u \le r$ and $d \mid v - u$, so $r + d \le v \le k+1$.

Lemma 8. If (a_i) is large, then r + d > k + 1 and $a_i = i$ for all $0 \le i < r + d$.

Proof. Since (a_i) is large and has period d and offset r, the period (a_r, \ldots, a_{r+d-1}) must have an element that is larger than k, so by Lemma 2 we must have r + d - 1 > k.

We already have $a_i = i$ for i < r. Now we show that $a_i = i$ for $r \le i \le k$. By Lemma 6 we have $d \mid a_i - i$ but $r \le i \le k$. Since k - r + 1 > d, this means that $a_i = i$ for $i \le k$.

Finally, one can show inductively that $a_i = i$ for k < i < r + d. Indeed, if $a_j = j$ for all j < i, then $a_i \ge i$ (otherwise $a_i = a_j$ for some j < i, but then $r \le j$ and i < r + d means that $d \nmid j - i$.) However, $a_i + (n - i) = a_i + a_{n-i} \le n$, so $a_i = i$.

Thus large sequences are determined by r and d. It is not hard to check that all sequences of the form $a_i = i$ for i < r + d and with period d and offset r are n-sequences. There are (n-k-1)(n+k+2)/2 possible choices of (r,d) where $0 \le r < n$, $d \ge 1$, and $k+1 < r+d \le n$.

For small sequences, for a given period d and offset r, we need to choose the period (a_r, \ldots, a_{r+d-1}) satisfying $r \leq aj \leq k$ and $d \mid a_j - j$ for $r \leq j < r + d$. There are g(k+1-r,d) such choices, where we define g(x,d) to be $(p+1)^q p^{d-q}$ with p = |x/d| and q = x - dp.

Furthermore, if d is even then there are g(k+1,d) choices for the period (a_0,\ldots,a_{d-1}) satisfying $d \mid a_j - j - d/2$ for j < d. Again it is not hard to check that, once these choices are made, then the resulting sequence is an n-sequence.

Thus the total number of n-sequences is

$$f(n) = 1 + \frac{(n-k-1)(n+k+2)}{2} + \sum_{d'=1}^{\lfloor (k+1)/2 \rfloor} g(k+1,2d') + \sum_{r=0}^{k} \sum_{d=1}^{k+1-r} g(k+1-r,d).$$
 (1)

Now, to show that $f(n) > c_1 \lambda^n$ for some c_1 , we note that

$$f(n) > g\left(k+1, \left|\frac{k+1}{3}\right|\right) \ge 3^{\lfloor (k+1)/3 \rfloor} > 3^{n/6} - 1.$$

To show that $f(n) < c_2 \lambda^n$ for some c_2 , it actually suffices to show that there is a positive real number c_3 such that for all positive integers x,

$$\sum_{d=1}^{x} g(x,d) \leqslant c_3 3^{x/3}.$$

In fact, the following lemma suffices, as it bounds the left hand side of the above inequality by a pair of geometric series with initial term $3^{x/3}$:

Lemma. For positive d, x, we have:

$$g(x,d) \le \begin{cases} 3^{x/3} \left(\frac{64}{81}\right)^{x/3-d}, & \text{if } d \le x/3; \\ 3^{x/3} \left(\frac{8}{9}\right)^{d-x/3}, & \text{if } d \ge x/3. \end{cases}$$

Proof. There are a few key observations needed, all of which are immediate from the definition:

- (x, d) is the maximum product of a sequence of d integers that sums to x.
- For any positive integer k, we have $q(kx, kd) = q(x, d)^k$.
- If $2d \le x \le 3d$, then $g(x,d) = 2^{3d-x}3^{x-2d}$. Likewise, if $3d \le x \le 4d$ then $g(x,d) = 3^{4d-x}4^{x-3d}$

With these observations, if $d \leq x/3$, then

$$3^{4(x-3d)}g(3x,3d) \le g(3x+12(x-3d),3d+4(x-3d)) = g(15x-36d,4x-9d)$$

To calculate g(15x - 36d, 4x - 9d), note that

$$3(4x - 9d) = 12x - 27d \le 15x - 36d,$$

$$4(4x - 9d) = 16x - 36d \ge 15x - 36d,$$

so

$$g(15x - 36d, 4x - 9d) = 3^{4(4x - 9d) - (15x - 36d)} 4^{(15x - 36d) - 3(4x - 9d)} = 3^x 4^{3(x - 3d)}.$$

Thus

$$g(x,d)^3 = g(3x,3d) = \frac{3^{4(x-3d)}g(3x,3d)}{3^{4(x-3d)}} \leqslant \frac{3^x 4^{3(x-3d)}}{3^{4(x-3d)}} = 3^x \left(\frac{64}{81}\right)^{x-3d},$$

which completes the proof of the first claim. Likewise, if $d \ge x/3$,

$$3^{2(3d-x)}g(3x,3d)3\leqslant g(3x+6(3d-x),3d+2(3d-x))=g(18d-3x,9d-2x).$$

Again we have

$$2(9d - 2x) \le 18 - 3x \le 18 - 3x + 3(3d - x) = 3(9d - 2x),$$

so

$$g(18d - 3x, 9d - 2x) = 2^{3(9d - 2x) - (18d - 3x)}3^{(18d - 3x) - 2(9d - 2x)} = 2^{3(3d - x)}3^{x}.$$

Thus

$$g(x,d)^3 = g(3x,3d) = \frac{2^{3(3d-x)}g(3x,3d)}{3^{2(3d-x)}} \leqslant \frac{2^{3(3d-x)3^x}}{3^{2(3d-x)}} = 3^x \left(\frac{8}{9}\right)^{3d-x},$$

from which the second claim follows.

Common remarks. The best possible value of c_1 is constrained by n=1: in this case, f(1)=2, which means that $c_1>2\cdot 3^{-1/6}\approx 1.66537$.

With a careful analysis one can show that the best possible value of c_2 is $\frac{236567}{4930}3^{1/3} \approx 69.20662$.

Combinatorics

C1. A ± 1 -sequence is a sequence of 2022 numbers a_1, \ldots, a_{2022} , each equal to either +1 or -1. Determine the largest C so that, for any ± 1 -sequence, there exists an integer k and indices $1 \le t_1 < \ldots < t_k \le 2022$ so that $t_{i+1} - t_i \le 2$ for all i, and

$$\left| \sum_{i=1}^{k} a_{t_i} \right| \geqslant C.$$

(Czech Republic)

Answer: The answer is C = 506.

Solution. First, we prove that this can always be achieved. Without loss of generality, suppose at least $\frac{2022}{2} = 1011$ terms of the ± 1 -sequence are ± 1 . Define a subsequence as follows: starting at t = 0, if $a_t = \pm 1$ we always include a_t in the subsequence. Otherwise, we skip a_t if we can (i.e. if we included a_{t-1} in the subsequence), otherwise we include it out of necessity, and go to the next t. Clearly, this subsequence will include all ± 1 s. Also, for each ± 1 included in the sequence, a ± 1 must have been skipped, so at most ± 1 must be included. Hence the sum is at least ± 1 1011 ± 1 505 ± 1 506, as desired.

Next, we prove that, for the ± 1 -sequence

$$(\{-1\}, \{+1, +1\}, \{-1, -1\}, \{+1, +1\}, \dots, \{+1, +1\}, \{-1, -1\}, \{+1\}),$$

each admissible subsequence a_{t_i} has $-506 \le \sum_i a_{t_i} \le 506$. We say that the terms inside each curly bracket is a *block*. In total, there are 1012 blocks - 506 of them hold +1-s, and 506 of them hold -1s. (The two blocks at each end hold 1 number each, each other block holds 2.)

Suppose an admissible subsequence includes terms from k blocks holding +1-s. Then, in each -1-pair in between the +1-pairs, the subsequence must also include at least one -1. There can be at most two +1s included from each +1-block, and at least one -1 must be included from each -1-block, so the sum is at most 2k - (k - 1) = k + 1.

For k < 506, this is at most 506. If k = 506, one of the +1-blocks must be the one at the end, meaning it can only include one +1, so that the maximum in this case is only k, not k + 1, so in this case the sum is also at most 506.

Hence we have shown that for any admissible subsequence, $\sum_i a_{t_i} \leq 506$. Analogously we can show that $-506 \leq \sum_i a_{t_i}$, meaning that $C \leq 506$ as desired.

Comment. A possible reformulation of the problem is the following.

2022 buckets of water are arranged in a row, each coloured either red or blue. Sally the salmon plays a game in the following way: first, she chooses any bucket she likes to start in. Then, any number of times she may jump either to the next bucket in the row, or across it to land in the bucket after that. (She may not jump across more than one bucket.) At any point, she may finish the game. At that time, her score is the absolute value of the difference between the number of red and blue buckets she visited during the game. Determine the largest C so that no matter how the buckets are coloured, Sally can achieve a score of at least C.

C2. The Bank of Oslo issues coins made out of two types of metal: aluminium (denoted A) and copper (denoted C). Morgane has n aluminium coins, and n copper coins, and arranges her 2n coins in a row in some arbitrary initial order. Given a fixed positive integer $k \leq 2n$, she repeatedly performs the following operation: identify the largest subsequence containing the k-th coin from the left which consists of consecutive coins made of the same metal, and move all coins in that subsequence to the left end of the row. For example, if n = 4 and k = 4, the process starting from the configuration AACCCACA would be

$$AACCCACA \rightarrow CCCAAACA \rightarrow AAACCCCA \rightarrow CCCCAAAA \rightarrow \cdots$$

Find all pairs (n, k) with $1 \le k \le 2n$ such that for every initial configuration, at some point of the process there will be at most one aluminium coin adjacent to a copper coin.

(France)

Answer: All pairs (n,k) such that $n \le k \le \frac{3n+1}{2}$.

Solution. Define a *block* to be a maximal subsequence of consecutive coins made out of the same metal, and let M^b denote a block of b coins of metal M. The property that there is at most one aluminium coin adjacent to a copper coin is clearly equivalent to the configuration having two blocks, one consisting of all A-s and one consisting of all C-s.

First, notice that if k < n, the sequence $A^{n-1}C^{n-1}AC$ remains fixed under the operation, and will therefore always have 4 blocks. Next, if $k > \frac{3n+1}{2}$, let a = k - n - 1, b = 2n - k + 1. Then k > 2a + b, k > 2b + a, so the configuration $A^aC^bA^bC^a$ will always have four blocks:

$$A^aC^bA^bC^a \to C^aA^aC^bA^b \to A^bC^aA^aC^b \to C^bA^bC^aA^a \to A^aC^bA^bC^a \to \dots$$

Therefore a pair (n, k) can have the desired property only if $n \le k \le \frac{3n+1}{2}$. We claim that all such pairs in fact do have the desired property. Clearly, the number of blocks in a configuration cannot increase, so whenever the operation is applied, it either decreases or remains constant. We show that unless there are only two blocks, after a finite amount of steps the number of blocks will decrease.

Consider an arbitrary configuration with $c \ge 3$ blocks. We note that as $k \ge n$, the leftmost block cannot be moved, because in this case all n coins of one type are in the leftmost block, meaning there are only two blocks. If a block which is not the leftmost or rightmost block is moved, its neighbor blocks will be merged, causing the number of blocks to decrease.

Hence the only case in which the number of blocks does not decrease in the next step is if the rightmost block is moved. If c is odd, the leftmost and the rightmost blocks are made of the same metal, so this would merge two blocks. Hence $c \ge 4$ must be even. Suppose there is a configuration of c blocks with the i-th block having size a_i so that the operation always moves the rightmost block:

$$A^{a_1} \dots A^{a_{c-1}} C^{a_c} \to C^{a_c} A^{a_1} \dots A^{a_{c-1}} \to A^{a_{c-1}} C^{a_c} A^{a_1} \dots C^{a_{c-2}} \to \dots$$

Because the rightmost block is always moved, $k \ge 2n + 1 - a_i$ for all i. Because $\sum a_i = 2n$, summing this over all i we get $ck \ge 2cn + c - \sum a_i = 2cn + c - 2n$, so $k \ge 2n + 1 - \frac{2n}{c} \ge \frac{3n}{2} + 1$. But this contradicts $k \le \frac{3n+1}{2}$. Hence at some point the operation will not move the rightmost block, meaning that the number of blocks will decrease, as desired.

C3. In each square of a garden shaped like a 2022 × 2022 board, there is initially a tree of height 0. A gardener and a lumberjack alternate turns playing the following game, with the gardener taking the first turn:


- The gardener chooses a square in the garden. Each tree on that square and all the surrounding squares (of which there are at most eight) then becomes one unit taller.
- The lumberjack then chooses four different squares on the board. Each tree of positive height on those squares then becomes one unit shorter.

We say that a tree is majestic if its height is at least 10^6 . Determine the largest number K such that the gardener can ensure there are eventually K majestic trees on the board, no matter how the lumberjack plays.

(Colombia)

Answer: $K = 5 \cdot \frac{2022^2}{9} = 2271380$. In general, for a $3N \times 3N$ board, $K = 5N^2$.

Solution. We solve the problem for a general $3N \times 3N$ board. First, we prove that the lumberjack has a strategy to ensure there are never more than $5N^2$ majestic trees. Giving the squares of the board coordinates in the natural manner, colour each square where at least one of its coordinates are divisible by 3, shown below for a 9×9 board:



Then, as each 3×3 square on the board contains exactly 5 coloured squares, each move of the gardener will cause at most 4 trees on non-coloured squares to grow. The lumberjack may therefore cut those trees, ensuring no tree on a non-coloured square has positive height after his turn. Hence there cannot ever be more majestic trees than coloured squares, which is $5N^2$.

Next, we prove the gardener may ensure there are $5N^2$ majestic trees. In fact, we prove this statement in a modified game which is more difficult for the gardener: on the lumberjack's turn in the modified game, he may decrement the height of *all* trees on the board except those the gardener did not just grow, in addition to four of the trees the gardener just grew. Clearly, a sequence of moves for the gardener which ensures that there are K majestic trees in the modified game also ensures this in the original game.

Let $M = \binom{9}{5}$; we say that a map is one of the M possible ways to mark 5 squares on a 3×3 board. In the modified game, after the gardener chooses a 3×3 subboard on the board, the lumberjack chooses a map in this subboard, and the total result of the two moves is that each tree marked on the map increases its height by 1, each tree in the subboard which is not in the map remains unchanged, and each tree outside the subboard decreases its height by 1. Also note that if the gardener chooses a 3×3 subboard Ml times, the lumberjack will have to choose some map at least l times, so there will be at least 5 trees which each have height $\geq l$.

The strategy for the gardener will be to divide the board into N^2 disjoint 3×3 subboards, number them $0, \ldots, N^2 - 1$ in some order. Then, for $b = N^2 - 1, \ldots, 0$ in order, he plays $10^6 M(M+1)^b$ times on subboard number b. Hence, on subboard number b, the moves on that subboard will first ensure 5 of its trees grows by at least $10^6 (M+1)^b$, and then each move after that will decrease their heights by 1. (As the trees on subboard b had height 0 before the gardener started playing there, no move made on subboards b decreased their heights.) As the gardener makes $10^6 M(M+1)^{b-1} + \ldots = 10^6 ((M+1)^b - 1)$ moves after he finishes playing on subboard b, this means that on subboard b, there will be 5 trees of height at least $10^6 (M+1)^b - 10^6 ((M+1)^b - 1) = 10^6$, hence each of the subboard has 5 majestic trees, which was what we wanted.



Let n > 3 be a positive integer. Suppose that n children are arranged in a circle, and n coins are distributed between them (some children may have no coins). At every step, a child with at least 2 coins may give 1 coin to each of their immediate neighbours on the right and left. Determine all initial distributions of coins from which it is possible that, after a finite number of steps, each child has exactly one coin.

(Israel)

Answer: All distributions where $\sum_{i=1}^{n} ic_i = \frac{n(n+1)}{2} \pmod{n}$, where c_i denotes the number of coins the *i*-th child starts with.

Solution 1.

Number the children $1, \ldots, n$, and denote the number of coins the *i*-th child has by c_i . A step of this process consists of reducing some c_i by 2, and increasing c_{i-1}, c_{i+1} by 1. (Indices are considered (mod n).) Because (i-1)-2i+(i+1)=0, the quantity $\sum_{i=1}^{n}ic_{i}\pmod{n}$ will be invariant under this process. Hence a necessary condition for the children to end up with an uniform distribution of coins is that

$$\sum_{i=1}^{n} ic_i = \frac{n(n+1)}{2} \pmod{n}.$$

We will show that this condition is also sufficient. Consider an arbitrary initial distribution of coins. First, whenever child i has more than one coin and $i \neq n$, have child i pass coins to its neighbors. (Child i does nothing.) Then, after some amount of such steps, it must eventually become impossible to do any more steps because no child except perhaps child i has more than 1 coin. (To see this, consider e.g. the quantity $\sum_{i=1}^{n-1} i^2 c_i$, which (as $(i-1)^2 + (i+1)^2 > 2i^2$) increases at each step.)

Hence we can reach a state of the form $(z_1, \ldots, z_{n-1}, M)$, where $z_i = 0$ or 1. Call such states semi-uniform states of irregularity M.

Lemma. If there is a string of children having coins $a, 1, \dots, 1, b, 1, \dots, 1, c$, with $b \ge 2$, after some sequence of steps we may reach the state $a+1, 1, \dots, 1, b-2, 1, \dots, 1, c+1$. We call performing

this sequence of steps long-passing coins.

Proof. This is simply repeated application of the operation. We prove the lemma by induction on k. For k=0, this is just the operation of the problem. If k=1, have the child with b coins pass coins, then both of their neighbors pass coins, then the child with b coins pass coins again. For $k \ge 2$, first, have the child with b coins pass coins, then have both their neighbors send coins, giving the state

$$a, \underbrace{1, \dots, 1}^{k-2 \text{ ones}}, 2, 0, b, 0, 2, \underbrace{1, \dots, 1}^{k-2 \text{ ones}}, c.$$

Now set aside the children with a, b and c coins, and have each child with 2 coins give them to their neighbors until there are no such children remaining. This results in the state

$$a+1,0,\overbrace{1,\ldots,1}^{k-2 \text{ ones}},b,\overbrace{1,\ldots,1}^{k-2 \text{ ones}},0,c+1.$$

By the induction hypothesis, we can have the child with b coins may pass a coin to each of the children with 0 coins, proving the lemma.

Claim. We can reach a semi-uniform state of irregularity $M \leq 2$.

Proof. If M > 3, because there are only n coins in total, there must be at least two children with 0 coins. Consider the arc of the circle spanned by the two such children closest to the child with M coins. It has the form

$$0, \overbrace{1, \dots, 1}^{a \text{ ones}}, M, \overbrace{1, \dots, 1}^{b \text{ ones}}, 0$$

If a = b, applying the previous lemma we can have the child with M coins long-pass a coin to each of the children with 0 coins, which yields a semi-uniform state with lower M. Otherwise, WLOG a > b, so we can have the child with M coins long-pass a coin to each of the children at distance b from it, reaching a state of the form $(\alpha := a - b - 1, \beta := b)$

$$0,\overbrace{1,\ldots,1}^{\alpha \text{ ones}},2,\overbrace{1,\ldots,1}^{\beta \text{ ones}},M-2,\overbrace{1,\ldots,1}^{c \text{ ones}}$$

The children in the rightmost string of ones need make no further moves, so consider only the leftmost string. If $\alpha < \beta$, have the child with 2 coins long-pass coins to the child with 0 coins to its left and some child with 1 coin to its right, reaching a new state of the form

 $0, 1, \ldots, 1, 2, 1, \ldots, 1, M-2$ with a smaller β . As β cannot decrease indefinitely, eventually $\alpha \geqslant \beta$. If $\alpha = \beta$, have the child with 2 coins long-pass to the child with M coins and the child with 0 coins, reaching a semi-uniform state of irregularity M-1 as desired. Otherwise, $\alpha < \beta$, so have the child with 2 coins long-pass to the child with M coins and a child with 1 coin, reaching a state of the form

$$0,\overbrace{1,\ldots,1}^{x \text{ ones}},2,\overbrace{1,\ldots,1}^{y \text{ ones}},0,\overbrace{1,\ldots,1}^{z \text{ ones}},M-1$$

Now, consider only the substring between the two children with 0 coins, which has the form x ones y ones

 $0, 1, \dots, 1, 2, 1, \dots, 1, 0$. Repeatedly have the child in this substring with 2 coins long-pass to the closest child with 0 coins and some other child. If the other child has 1 coin, we have a new x ones

strictly shorter substring of the form 0, 1, ..., 1, 2, 1, ..., 1, 0. Hence eventually it must happen that the other child also has 0 coins, at which point we reach a semi-uniform state of irregularity M-1, proving the claim.

We have now shown that we can reach a semi-regular state of irregularity $M \leq 2$, If M = 1, each child must have one coin, as desired. Otherwise, we must have M = 2, so there is one child with 0 coins, one child with 2 coins, and the remaining children all have 1 coin. Recall that the state we started with satisfied the invariant

$$\sum_{i=1}^{n} ic_i = \frac{n(n+1)}{2} \pmod{n}$$

Because each step preserves this invariant, this must also be true of the current state. Number the children so that the child with M coins is child number n, and suppose the child with 0 coins is child k. Then $\frac{n(n+1)}{2} = \sum_{i=1}^{n} ic_i = \left(\sum_{i=1}^{n} 1 \cdot c_i\right) - k = \frac{n(n+1)}{2} - k \pmod{n}$, so $k = 0 \pmod{n}$. But this is impossible, as no child except the child with M coins has an index divisible by n. Hence we cannot end up in a semi-regular state of irregularity 2, so we are done.

Solution 2. Encode the sequence c_i as a polynomial $p(x) = \sum_i a_i x_i$. The cyclic nature of the problem makes it natural to work modulo $x^n - 1$. Child i performing a step is equivalent to adding $x^i(x-1)^2$ to the polynomial, and we want to reach the polynomial $q(x) = 1 + x + \ldots + x^{n-1}$. Since we only add multiples of $(x-1)^2$, this is only possible if p(x) = q(x) modulo the ideal generated by $x^n - 1$ and $(x-1)^2$, i.e.

$$(x^{n}-1,(x-1)^{2})=(x-1)\left(\frac{x^{n}-1}{x-1},x-1\right)=(x-1)\cdot(n,(x-1))$$

This is equivalent to p(1) = q(1) (which simply translates to the condition that there are n coins) and p'(1) = q'(1) (mod n), which translates to the invariant described in solution 1.

C5. Let $m, n \ge 2$ be integers, let X be a set with n elements, and let X_1, X_2, \ldots, X_m be pairwise distinct non-empty, not necessary disjoint subsets of X. A function $f: X \to \{1, 2, \ldots, n+1\}$ is called *nice* if there exists an index k such that

$$\sum_{x \in X_k} f(x) > \sum_{x \in X_i} f(x) \text{ for all } i \neq k.$$

Prove that the number of nice functions is at least n^n .

(Germany)

Solution. For a subset $Y \subseteq X$, we write f(Y) for $\sum_{y \in Y} f(y)$. Note that a function $f: X \to \{1, \ldots, n+1\}$ is nice, if and only if $f(X_i)$ is maximized by a unique index $i \in \{1, \ldots, m\}$.

We will first investigate the set \mathcal{F} of functions $f: X \to \{1, \dots, n\}$; note that $|\mathcal{F}| = n^n$. For every function $f \in \mathcal{F}$, define a corresponding function $f^+: X \to \{1, 2, \dots, n+1\}$ in the following way: Pick some set X_l that maximizes the value $f(X_l)$.

- For all $x \in X_l$, define $f^+(x) = f(x) + 1$.
- For all $x \in X \setminus X_l$, define $f^+(x) = f(x)$.

Claim. The resulting function f^+ is nice.

Proof. Note that $f^+(X_i) = f(X_i) + |X_i \cap X_l|$ holds for all X_i . We show that $f^+(X_i)$ is maximized at the unique index i = l. Hence consider some arbitrary index $j \neq l$. Then $X_l \subset X_j$ is impossible, as this would imply $f(X_j) > f(X_l)$ and thereby contradict the choice of set X_l ; this in particular yields $|X_l| > |X_j \cap X_l|$.

$$f^{+}(X_{l}) = f(X_{l}) + |X_{l}| \ge f(X_{j}) + |X_{l}| > f(X_{j}) + |X_{j} \cap X_{l}| = f^{+}(X_{j})$$

The first inequality follows since X_l was chosen to maximize the value $f(X_l)$. The second (strict) inequality follows from $|X_l| > |X_j \cap X_l|$ as observed above. This completes the proof of the claim.

Next observe that function f can be uniquely reconstructed from f^+ : the claim yields that f^+ has a unique maximizer X_l , and by decreasing the value of f^+ on X_l by 1, we get we can fully determine the values of f. As each of the n^n functions $f \in \mathcal{F}$ yields a (unique) corresponding nice function $f^+: X \to \{1, 2, \ldots, n+1\}$, the proof is complete.

C6. Let n be a positive integer. We start with n piles of pebbles, each initially containing a single pebble. One can perform moves of the following form: choose two piles, take an equal number of pebbles from each pile and form a new pile out of these pebbles. For each positive integer n, find the smallest number of non-empty piles that one can obtain by performing a finite sequence of moves of this form.

(Croatia)

Answer: 1 if n is a power of two, and 2 otherwise.

Solution 1. The solution we describe is simple, but not the most effective one.

We can combine two piles of 2^{k-1} pebbles to make one pile of 2^k pebbles. In particular, given 2^k piles of one pebble, we may combine them as follows:

This proves the desired result in the case when n is a power of 2.

If n is not a power of 2, choose N such that $2^N < n < 2^{N+1}$. Let $m = n - 2^N$. Then $0 < m < 2^N$. Make a pile of 2^N pebbles and call it the *large* pile. (Alternatively, one can be more efficient and make a pile of 2^M pebbles where $m \le 2^M$.) Since n is not a power of two, there is at least one other pile with pebbles. All other piles have a single pebble (initial condition).

Choose one single pebble pile and remove the pebble and one pebble from the *large* pile and form a pile of 2 pebbles. If $m < 2^N - 1$, remove another pebble from the *large* pile and one pebble from the 2-pile and form a new pile of 2 pebbles. Repeat until the *large* pile contains exactly m pebbles.

At this point we have one pile of m pebbles, one pile of 2 pebbles, and the rest are single pebble piles. There must be $n-m-2=2^N-2$ single piles. Combine two and two into piles of two pebbles. Then there are 2^{N-1} piles of two pebbles, which we can make into one pile of 2^N pebbles. We are left with exactly two piles of pebbles.

Lastly we will prove that it is not possible to form a single pile with all pebbles when n is not a power of two. A move consists of choosing two piles of say a and b pebbles, then removing $c \leq \min(a, b)$ pebbles from both piles, and forming a new pile with 2c pebbles. If we include piles of zero pebbles, then this move changes the number of pebbles in three piles as follows (and leaves all other piles unchanged):

$$\begin{array}{ccc} a & \rightarrow & a - c \\ b & \rightarrow & b - c \\ 0 & \rightarrow & 2c \end{array}$$

Assume that after the move the number of pebbles in each pile is divisible by an odd integer m. In particular, $m \mid 2c$, $m \mid a - c$ and $m \mid b - c$. Since m is odd, it follows that $m \mid c$, and then that $m \mid a$ and $m \mid b$. Hence also before the move the number of pebbles in each pile is divisible by the integer m.

If n is not a power of 2, then n is divisible by an odd integer m > 1. In order to make a single pile of n pebbles, we would have to start with a distribution in which the number of pebbles in each pile is divisible by the integer m. This is impossible when we start with all piles containing a single pebble.

Remarks on starting configurations From any starting configuration that is not a single pile, if there are at least two piles with at least two pebbles, we can remove one pebble from two such piles, and form a new pile with 2 pebbles. We can repeat this until we have one pile of 2 pebbles and the rest are single pebble piles, and then proceed as in the solution. Hence, if n is a power of two, we can make a single pile from any starting configuration.

If n is of the form $n = 2^k m$ where m > 1 is odd, then we can make a single pile from any starting configuration in which the number of pebbles in each pile is divisible by the integer m, otherwise two piles is the best we can do. Half of this is proven already. For the other half, assume we start with a configuration in which the number of pebbles in each pile is divisible by the integer m. Replace each pile of tm pebbles with a pile of t boulders. We now have a total of t boulders, hence we can make them into one pile of t boulders. Replacing the boulders with pebbles again, we are done.

Solution 2. We show an alternative strategy if n is not a power of 2. Write n in binary form: $n = 2^{i_1} + 2^{i_2} + \cdots + 2^{i_k}$, where $i_1 > i_2 > \cdots > i_k$. Now we make piles of sizes $2^{i_1}, 2^{i_2}, \ldots, 2^{i_k}$. We call the pile with 2^{i_1} the *large pile*, all the others are the *small piles*.

The strategy is the following: take the two smallest *small pile*. If they have the same size of 2^a , we make a pile of size 2^{a+1} . If they have different sizes, we double the smaller pile using the *large pile* (we allow the *large pile* to have a negative number of pebbles: later we prove that it is not possible). We call all the new piles *small*. When we have only one *small pile*, we terminate the process: we have at most 2 piles.

After each move we have one less number of piles, and all the piles have cardinality power of 2. The number of pebbles is decreasing, and at the end of the process, it has a size of $n - 2^{i_2+1} \ge n - 2^{i_1} > 0$, thus we can manage to have two piles.

Solution 3. Throughout the solution, we will consider the moves in reverse order. Namely, imagine we have some piles of pebbles, and we are allowed to perform moves as follows: take a pile with an even number of pebbles, split it into two equal halves and add the pebbles from each half to a different pile, possibly forming new piles (we may assume for convenience that there are infinitely many empty piles at any given moment). Given a configuration of piles \mathcal{C} , we will use $|\mathcal{C}|$ to denote the number of non-empty piles in \mathcal{C} . Given two configurations \mathcal{C}_1 , \mathcal{C}_2 , we will say that \mathcal{C}_2 is reachable from \mathcal{C}_1 if \mathcal{C}_2 can be obtained by performing a finite sequence of moves starting from \mathcal{C}_1 . Call a configuration of piles \mathcal{C}

- simple if each (non-empty) pile in C consists of a single pebble;
- good if at least one (non-empty) pile in \mathcal{C} has an even number of pebbles and the numbers of pebbles on the piles in \mathcal{C} have no non-trivial odd common divisor (\mathcal{C} has the odd divisor property);
- solvable if there exists a simple configuration which is reachable from \mathcal{C} .

The problem asks to find the smallest number of non-empty piles in a solvable configuration consisting of n pebbles. We begin the process of answering this question by making the following observation:

Lemma 1. Let \mathcal{C} be a configuration of piles. Let \mathcal{C}' be a configuration obtained by applying a single move to \mathcal{C} . Then

- (i) if C' has the odd divisor property, then so does C;
- (ii) the converse to (i) holds if $|\mathcal{C}'| \ge |\mathcal{C}|$.

Proof. Suppose that the move consists of splitting a pile of size 2a and adding a pebbles to each of two piles of sizes b and c. Here, a is a positive integer and b, c are non-negative integers. Thus, \mathcal{C}' can be obtained from \mathcal{C} by replacing the piles of sizes 2a, b, c by two piles of sizes a + b and a + c. Note that the extra assumption $|\mathcal{C}'| \ge |\mathcal{C}|$ of part (ii) holds if and only if at least one of b, c is zero.

- (i) Suppose \mathcal{C} doesn't have the odd divisor property, i.e. there exists an odd integer d > 1 such that the size of each pile in \mathcal{C} is divisible by d. In particular, 2a, b, c are multiples of d, so since d is odd, it follows that a, b, c are all divisible by d. Thus, a + b and a + c are also divisible by d, so d divides the size of each pile in \mathcal{C}' . In conclusion, \mathcal{C}' doesn't have the odd divisor property.
- (ii) If \mathcal{C}' doesn't have the odd divisor property and at least one of b, c is zero, then there exists an odd integer d > 1 such that the size of each pile in \mathcal{C}' is divisible by d. In particular, d divides a + b and a + c, so since at least one of these numbers is equal to a, it follows that d divides a. But then d must divide all three of a, b and c, and hence it certainly divides 2a, b and c. Thus, \mathcal{C} doesn't have the odd divisor property, as desired.

Lemma 2. If C_2 is reachable from C_1 and C_2 has the odd divisor property, then so does C_1 . In particular, any solvable configuration has the odd divisor property.

Proof. The first statement follows by inductively applying part (i) of Lemma 1. The second statement follows from the first because every simple configuration has the odd divisor property.

The main claim is the following:

Lemma 3. Let C be a good configuration. Then there exists a configuration C' with the following properties:

- \mathcal{C}' is reachable from \mathcal{C} and $|\mathcal{C}'| > |\mathcal{C}|$;
- C' is either simple or good.

Proof. Call a configuration *terminal* if it is a counterexample to the claim. The following claim is at the heart of the proof:

Claim. Let a_1, \ldots, a_k be the numbers of pebbles on the non-empty piles of a terminal configuration \mathcal{C} . Then there exists a unique $i \in [k]$ such that a_i is even. Moreover, for all $t \ge 1$ we have $a_j \equiv \frac{a_i}{2} \pmod{2^t}$ for all $j \ne i$.

Proof of Claim. Since the configuration is good, there must exist $i \in [k]$ such that a_i is even. Moreover, by assumption, if we split the pile with a_i pebbles into two equal halves, the resulting configuration will not be good. By part (ii) of Lemma 2,the only way this can happen is that $\frac{a_i}{2}$ and a_j for all $j \neq i$ are odd. To prove the second assertion, we proceed by induction on t, with the case t = 1 already being established. If $t \geq 2$, then split the pile with a_i pebbles into two equal halves and move one half to the pile with a_j pebbles. Since $\frac{a_i}{2}$ and a_j are both odd, $a_j + \frac{a_i}{2}$ is even, so by part (ii) of Lemma 2, the resulting configuration \mathcal{C}' is good. Thus, \mathcal{C}' is terminal, so by the induction hypothesis, we have $\frac{a_i}{2} \equiv \frac{1}{2}(a_j + \frac{a_i}{2})(\mod 2^{t-1})$, whence $a_j \equiv \frac{a_i}{2}(\mod 2^t)$, as desired.

Suppose for contradiction that there exists a configuration as in the Claim. It follows that there exists $i \in [k]$ and an odd integer x such that $a_i = 2x$ and $a_j = x$ for all $j \neq i$. Thus, x is an odd common divisor of a_1, \ldots, a_k , so by the odd divisor property, we must have x = 1. But then we can obtain a simple configuration by splitting the only pile with two pebbles into two piles each consisting of a single pebble, which is a contradiction.

With the aid of Lemmas 2 and 3, it is not hard to characterise all solvable configurations: Lemma 4. A configuration of piles C is solvable if and only if it is simple or good.

Proof. (\Longrightarrow) Suppose \mathcal{C} is not simple. Then since we have to be able to perform at least one move, there must be at least one non-empty pile in \mathcal{C} with an even number of pebbles. Moreover, by Lemma 2, \mathcal{C} has the odd divisor property, so it must be good.

 (\longleftarrow) This follows by repeatedly applying Lemma 3 until we reach a simple configuration. Note that the process must stop eventually since the number of non-empty piles is bounded from above.

Finally, the answer to the problem is implied by the following corollary of Lemma 4: Lemma 5. Let n be a positive integer. Then

- (i) a configuration consisting of a single pile of n pebbles is solvable if and only if n is a power of two;
- (ii) if $n \ge 2$, then the configuration consisting of piles of sizes 2 and n-2 is good.
- *Proof.* (i) By Lemma 4, this configuration is solvable if and only if either n = 1 or n is even and has no non-trivial odd divisor, so the conclusion follows.
- (ii) Since 2 is even and has no non-trivial odd divisor, this configuration is certainly good, so the conclusion follows by Lemma 4.

Common remarks. Instead of choosing pebbles from two piles, one could allow choosing an equal number of pebbles from each of k piles, where $k \ge 2$ is a fixed (prime) integer. However, this seems to yield a much harder problem – if k = 3, numerical evidence suggests the same answer as in the case k = 2 (with powers of two replaced by powers of three), but the case k = 5 is already unclear.

C7. Lucy starts by writing s integer-valued 2022-tuples on a blackboard. After doing that, she can take any two (not necessarily distinct) tuples $\mathbf{v} = (v_1, \dots, v_{2022})$ and $\mathbf{w} = (w_1, \dots, w_{2022})$ that she has already written, and apply one of the following operations to obtain a new tuple:

$$\mathbf{v} + \mathbf{w} = (v_1 + w_1, \dots, v_{2022} + w_{2022})$$

 $\mathbf{v} \vee \mathbf{w} = (\max(v_1, w_1), \dots, \max(v_{2022}, w_{2022}))$

and then write this tuple on the blackboard.

It turns out that, in this way, Lucy can write any integer-valued 2022-tuple on the blackboard after finitely many steps. What is the smallest possible number s of tuples that she initially wrote?

(Czech Republic)

Answer: The smallest possible number is s = 3.

Solution. We solve the problem for n-tuples for any $n \ge 3$: we will show that the answer is s = 3, regardless of the value of n.

First, let us briefly introduce some notation. For an n-tuple \mathbf{v} , we will write \mathbf{v}_i for its i-th coordinate (where $1 \leq i \leq n$). For a positive integer n and a tuple \mathbf{v} we will denote by $n \cdot \mathbf{v}$ the tuple obtained by applying addition on \mathbf{v} with itself n times. Furthermore, we denote by $\mathbf{e}(i)$ the tuple which has i-th coordinate equal to one and all the other coordinates equal to zero. We say that a tuple is *positive* if all its coordinates are positive, and *negative* if all its coordinates are negative.

We will show that three tuples suffice, and then that two tuples do not suffice.

Three tuples suffice. Write c for the constant-valued tuple c = (-1, ..., -1).

We note that it is enough for Lucy to be able to make the tuples $\mathbf{e}(1), \dots, \mathbf{e}(n), \mathbf{c}$; from those any other tuple \mathbf{v} can be made as follows. First we choose some positive integer k such that $k + \mathbf{v}_i > 0$ for all i. Then, by adding a positive number of copies of $\mathbf{c}, \mathbf{e}(1), \dots, \mathbf{e}(n)$, she can make

$$k\mathbf{c} + (k + \mathbf{v}_1) \cdot \mathbf{e}(1) + \cdots + (k + \mathbf{v}_n) \cdot \mathbf{e}(n),$$

which we claim is equal to \mathbf{v} . Indeed, this can be checked by comparing coordinates: the *i*-th coordinate of the right-hand side is $-k + (k + \mathbf{v}_i) = \mathbf{v}_i$ as needed.

Lucy can take her three starting tuples to be **a**, **b** and **c**, such that $\mathbf{a}_i = -i^2$, $\mathbf{b}_i = i$ and $\mathbf{c} = -1$ (as above).

For any $1 \le j \le n$, write $\mathbf{d}(j)$ for the tuple $2 \cdot \mathbf{a} + 4j \cdot \mathbf{b} + (2j^2 - 1) \cdot \mathbf{c}$, which Lucy can make by adding together \mathbf{a} , \mathbf{b} and \mathbf{c} repeatedly. This has *i*th term

$$\mathbf{d}(j)_i = 2\mathbf{a}_i + 4j\mathbf{b}_i + (2j^2 - 1)\mathbf{c}_i$$

= $-2i^2 + 4ij - (2j^2 - 1)$
= $1 - 2(i - j)^2$.

This is 1 if j = i, and at most -1 otherwise. Hence Lucy can produce the tuple $\mathbf{1} = (1, \dots, 1)$ as $\mathbf{d}(1) \vee \dots \vee \mathbf{d}(n)$.

She can then produce the constant tuple $\mathbf{0} = (0, \dots, 0)$ as $\mathbf{1} + \mathbf{c}$, and for any $1 \le j \le n$ she can then produce the tuple $\mathbf{e}(j)$ as $\mathbf{d}(j) \vee \mathbf{0}$. Since she can now produce $\mathbf{e}(1), \dots, \mathbf{e}(n)$ and already had \mathbf{c} , she can (as we argued earlier) produce any integer-valued tuple.

Two tuples do not suffice. We start with an observation: Let a be a non-negative real number and suppose that two tuples \mathbf{v} and \mathbf{w} satisfy $\mathbf{v}_j \geq a\mathbf{v}_k$ and $\mathbf{w}_j \geq a\mathbf{w}_k$ for some $1 \leq j, k \leq n$. Then we claim that the same inequality holds for $\mathbf{v} + \mathbf{w}$ and $\mathbf{v} \vee \mathbf{w}$: Indeed, the property for the sum is verified by an easy computation:

$$(\mathbf{v} + \mathbf{w})_j = \mathbf{v}_j + \mathbf{w}_j \geqslant a\mathbf{v}_k + a\mathbf{w}_k = a(\mathbf{v} + \mathbf{w})_k.$$

For the second operation, we denote by \mathbf{m} the tuple $\mathbf{v} \vee \mathbf{w}$. Then $\mathbf{m}_j \geq \mathbf{v}_j \geq a\mathbf{v}_k$ and $\mathbf{m}_j \geq \mathbf{w}_j \geq a\mathbf{w}_k$. Since $\mathbf{m}_k = \mathbf{v}_k$ or $\mathbf{m}_k = \mathbf{w}_k$, the observation follows.

As a consequence of this observation we have that if all starting tuples satisfy such an inequality, then all generated tuples will also satisfy it, and so we would not be able to obtain every integer-valued tuple.

Let us now prove that Lucy needs at least three starting tuples. For contradiction, let us suppose that Lucy started with only two tuples \mathbf{v} and \mathbf{w} . We are going to distinguish two cases. In the first case, suppose we can find a coordinate i such that $\mathbf{v}_i, \mathbf{w}_i \ge 0$. Both operations preserve the sign, thus we can not generate any tuple that has negative i-th coordinate. Similarly for $\mathbf{v}_i, \mathbf{w}_i \le 0$.

Suppose the opposite, i.e., for every i we have either $\mathbf{v}_i > 0 > \mathbf{w}_i$, or $\mathbf{v}_i < 0 < \mathbf{w}_i$. Since we assumed that our tuples have at least three coordinates, by pigeonhole principle there exist two coordinates $j \neq k$ such that \mathbf{v}_j has the same sign as \mathbf{v}_k and \mathbf{w}_j has the same sign as \mathbf{w}_k (because there are only two possible combinations of signs).

Without loss of generality assume that $\mathbf{v}_j, \mathbf{v}_k > 0$ and $\mathbf{w}_j, \mathbf{w}_k < 0$. Let us denote the positive real number $\mathbf{v}_j/\mathbf{v}_k$ by a. If $\mathbf{w}_j/\mathbf{w}_k \leq a$, then both inequalities $\mathbf{v}_j \geq a\mathbf{v}_k$ and $\mathbf{w}_j \geq a\mathbf{w}_k$ are satisfied. On the other hand, if $\mathbf{w}_j/\mathbf{w}_k \leq a$, then both $\mathbf{v}_k \geq (1/a)\mathbf{v}_j$ and $\mathbf{w}_k \geq (1/a)\mathbf{w}_j$ are satisfied. In either case, we have found the desired inequality satisfied by both starting tuples, a contradiction with the observation above.

Common remarks.

- 1. For $n \in \{1, 2\}$, two starting n-tuples are necessary and sufficient.
- 2. The operations +, \vee used in this problem are studied in the area of tropical geometry. However, as far as we know, familiarity with tropical geometry does not help when solving the problem.



Alice fills the fields of an $n \times n$ board with numbers from 1 to n^2 , each number being used exactly once. She then counts the total number of good paths on the board. A good path is a sequence of fields of arbitrary length (including 1) such that:

- (i) The first field in the sequence is one that is only adjacent to fields with larger numbers,
- (ii) Each subsequent field in the sequence is adjacent to the previous field,
- (iii) The numbers written on the fields in the sequence are in increasing order.

Two fields are considered adjacent if they share a common side. Find the smallest possible number of good paths Alice can obtain, as a function of n.

(Serbia)

Answer: $2n^2 - 2n + 1$.

Solution.

We will call any field that is only adjacent to fields with larger numbers a well. Other fields will be called non-wells. Let us make a second $n \times n$ board B where in each field we will write the number of good sequences which end on the corresponding field in the original board A. We will thus look for the minimal possible value of the sum of all entries in B.

We note that any well has just one good path ending in it, consisting of just the well, and that any other field has the number of good paths ending in it equal to the sum of this quantity for all the adjacent fields with smaller values, since a good path can only come into the field from a field of lower value. Therefore, if we fill in the fields in B in increasing order with respect to their values in A, it follows that each field not adjacent to any already filled field will receive a 1, while each field adjacent to already filled fields will receive the sum of the numbers already written on these adjacent fields.

We note that there is at least one well in A, that corresponding with the field with the entry 1 in A. Hence, the sum of values of fields in B corresponding to wells in A is at least 1. We will now try to minimize the sum of the non-well entries, i.e. of the entries in B corresponding to the non-wells in A. We note that we can ascribe to each pair of adjacent fields the value of the lower assigned number and that the sum of non-well entries will then equal to the sum of the ascribed numbers. Since the lower number is still at least 1, the sum of non-well entries will at least equal the number of pairs of adjacent fields, which is 2n(n-1). Hence, the total minimum sum of entries in B is at least $2n(n-1)+1=2n^2-2n+1$. The necessary conditions for the minimum to be achieved is for there to be only one well and for no two entries in B larger than 1 to be adjacent to each other.

We will now prove that the lower limit of $2n^2 - 2n + 1$ entries can be achieved. This amounts to finding a way of marking a certain set of squares, those that have a value of 1 in B, such that no two unmarked squares are adjacent and that the marked squares form a connected tree with respect to adjacency.

For n=1 and n=2 the markings are respectively the lone field and the L-trimino. Now, for n>2, let s=2 for $n\equiv 0,2\mod 3$ and s=1 for $n\equiv 1\mod 3$. We will take indices k and l to be arbitrary non-negative integers. For $n\geqslant 3$ we will construct a path of marked squares in the first two columns consisting of all squares of the form (1,i) where i is not of the form 6k+s and (2,j) where j is of the form 6k+s-1, 6k+s or 6+s+1. Obviously, this path is connected. Now, let us consider the fields (2,6k+s) and (1,6k+s+3). For each considered field (i,j) we will mark all squares of the form (l,j) for l>i and $(i+2k,j\pm 1)$. One can easily see that no set of marked fields will produce a cycle, that the only fields of the unmarked form (1,6k+s), $(2+2l+1,6k+s\pm 1)$ and $(2+2l,6k+s+3\pm 1)$ and that no two are adjacent, since

the consecutive considered fields are in columns of opposite parity. Examples of markings are given for n = 3, 4, 5, 6, 7, and the corresponding constructions for A and B are given for n = 5.

Common remarks.

- The construction can be achieved in different ways. For example, it can also be done recursively; we can complete any construction for n to a construction for n + 1.
- It is a natural idea to change the direction of the path: that way it can start anywhere, but only can end in a well, which exactly means that we cannot extend the path. This is just a reformulation of the problem, but can give some intuitions.

Let $\mathbb{Z}_{\geq 0}$ be the set of non-negative integers, and let $f: \mathbb{Z}_{\geq 0} \times \mathbb{Z}_{\geq 0} \to \mathbb{Z}_{\geq 0}$ be a bijection such that whenever $f(x_1, y_1) > f(x_2, y_2)$, we have $f(x_1 + 1, y_1) > f(x_2 + 1, y_2)$ and $f(x_1, y_1 + 1) > f(x_2, y_2 + 1)$.

Let N be the number of pairs of integers (x, y), with $0 \le x, y < 100$, such that f(x, y) is odd. Find the smallest and largest possible value of N.

(U.S.A.)

Answer: The optimal bounds are $2500 \le N \le 7500$.

Solution. We defer the constructions to the end of the solution. Instead, we begin by characterizing all such functions f, prove a formula and key property for such functions, and then solve the problem, providing constructions.

Characterization Suppose f satisfies the given relation. The condition can be written more strongly as

$$f(x_1, y_1) > f(x_2, y_2) \iff f(x_1 + 1, y_1) > f(x_2 + 1, y_2)$$

 $\iff f(x_1, y_1 + 1) > f(x_2, y_2 + 1).$

In particular, this means for any $(k, l) \in \mathbb{Z}^2$, f(x + k, y + l) - f(x, y) has the same sign for all x and y.

Call a non-zero vector $(k,l) \in \mathbb{Z}_{\geq 0} \times \mathbb{Z}_{\geq 0}$ a needle if f(x+k,y) - f(x,y+l) > 0 for all x and y. It is not hard to see that needles and non-needles are both closed under addition, and thus under scalar division (whenever the quotient lives in \mathbb{Z}^2).

In addition, call a positive rational number $\frac{k}{l}$ a grade if the vector (k, l) is a needle. (Since needles are closed under scalar multiples and quotients, this is well-defined.)

Claim. Grades are closed upwards.

Proof. Consider positive rationals $k_1/l_1 < k_2/l_2$ with k_1/l_1 a grade. Then:

- (k_1, l_1) is a needle
- so (k_1l_2, l_1l_2) is a needle,
- so (k_2l_1, l_1l_2) is a needle (as $k_2l_1 k_1l_2 > 0$ and (1, 0) is a needle).

Thus (k_2, l_2) is a needle, as wanted.

Claim. A grade exists.

Proof. If no positive integer n is a grade, then f(1,0) > f(0,n) for all n which is impossible.

Similarly, there is an n such that f(0,1) < f(n,0), thus 1/n is not a grade for some large n. That means that small positive rational values are not grades, then there is a switch, and after that all values are grades. Call the place of that switch α . Here α is the infimum of the grades.

Claim (Key property). If $x_1 + y_1 \alpha > x_2 + y_2 \alpha$ then $f(x_1, y_1) > f(x_2, y_2)$.

Proof. If both $x_1 \ge x_2$ and $y_1 \ge y_2$ this is clear.

Suppose $x_1 \geqslant x_2$ and $y_1 < y_2$. Then $\frac{x_1 - x_2}{y_2 - y_1} > \alpha$ is a grade. This gives $f(x_1, y_1) > f(x_2, y_2)$. Suppose $x_1 < x_2$ and $y_1 \geqslant y_2$. Then $\frac{x_2 - x_1}{u_1 - u_2} < \alpha$ is not a grade. This gives $f(x_2, y_2) < f(x_1, y_1)$.

From those observations we get the following claim.

Claim. The function f orders pairs (x, y) based on the value of $x + y\alpha$. If α is rational, tiebreaking is done by larger x- or y-coordinate (depending on whether α is a grade).

We can imagine this the following way: take a line with slope $-\frac{1}{\alpha}$ under the first quadrant of the plane. And we start to move this line upward (but it stays parallel to the original line). First it hits (0,0), so f(0,0) = 0. And each time the line hits a point p, f(p) is the number of points hit before. If $\alpha \in \mathbb{Q}$, it is possible that the line hits multiple points. Then those points are ordered the same way as their x or y coordinates, depending on whether α is a grade.

We understood the behaviour of f, now we need to focus on the region of $A = \{(x, y) \in \mathbb{Z}_{\geq 0} | x < 100, y < 100\}$. First, we can assume that α is irrational. If we change it a little bit in the right direction, the behaviour and values of the f function does not change in A. Claim.

$$f(x,y) + f(x+1,y+1) = f(x+1,y) + f(x,y+1) + 1.$$

Proof.

$$f(x+1,y+1) - f(x,y+1) =$$

$$\#\{(a,b) \in \mathbb{Z}_{\geq 0} \times \mathbb{Z}_{\geq 0} | x + (y+1)\alpha \leqslant a + b\alpha < (x+1) + (y+1)\alpha\} =$$

$$\#\{(a,b) \in \mathbb{Z}_{\geq 0} \times \mathbb{Z}_{> 0} | x + (y+1)\alpha \leqslant a + b\alpha < (x+1) + (y+1)\alpha\} +$$

$$\#\{(a,0) \in \mathbb{Z}_{\geq 0} \times \mathbb{Z}_{\geq 0} | (x+1) + y\alpha \leqslant a < (x+1) + (y+1)\alpha\} =$$

$$\#\{(a,b) \in \mathbb{Z}_{\geq 0} \times \mathbb{Z}_{\geq 0} | x + y\alpha \leqslant a + b\alpha < (x+1) + y\alpha\} + 1 = f(x+1,y) - f(x,y).$$

From this claim we immediately get that $2500 \le N \le 7500$; now we show that those bounds are indeed sharp.

Remember that if α is irrational then

$$f(a,b) = \# \{(x,y) \in \mathbb{Z}_{\geq 0} \times \mathbb{Z}_{\geq 0} \mid x + y\alpha < a + b\alpha \}.$$

Construction for 7500 Select $\alpha \approx 199.999$.

Claim.

- 1. f(n,0) = n for $0 \le n \le 100$.
- 2. $f(0, k) \equiv k \mod 2 \text{ for } 0 \le k \le 100.$

Proof.

1.
$$f(n,0) = \#\{(x,y) | x + y\alpha < n\} = \#\{(x,y) | x + 199y < n\} = n.$$

2.

$$f(0,k) = \#\{(x,y)|\ x + y\alpha < k\alpha\} = \sum_{l=0}^{k-1} \#\{(x,l)|\ x + l\alpha < k\alpha\}$$
$$= \sum_{l=0}^{k-1} \#\{x|\ x < (k-l)\alpha\} = \sum_{l=0}^{k-1} 200(k-l) - 1 = 200A - k$$

for some integer A.

From this claim, using the equality f(x,y) + f(x+1,y+1) = f(x+1,y) + f(x,y+1) + 1, we can prove that mod 2 the region A looks like the following: in the rows (-,2y) the remainders modulo 2 alternate, while the rows (-,2y+1) contain only odd numbers.

The numbers mod 2 in the construction for 7500.

Construction for 2500 Select $\alpha \approx 200.001$.

Claim.

- 1. f(n,0) = n for $0 \le n \le 100$.
- 2. $f(0, k) \equiv 0 \mod 2 \text{ for } 0 \le k \le 100.$

Proof.

- 1. As above.
- 2. Similarly to the above:

$$f(0,k) = \#\{(x,y)|\ x + y\alpha < k\alpha\} = \sum_{l=0}^{k-1} \#\{(x,l)|\ x + l\alpha < k\alpha\}$$
$$= \sum_{l=0}^{k-1} \#\{x|\ x < (k-l)\alpha\} = \sum_{l=0}^{k-1} 200(k-l) = 200A$$

for some integer A.

Similarly to the above, we can prove that mod 2 the region A looks like the following: in the rows (-, 2y) the remainder modulo 2 alternate, while the rows (-, 2y + 1) contain only even numbers.

The numbers mod 2 in the construction for 7500.

Common remarks.

• In the proposer's solution, an exact formula is proved in the case where α is irrational. Let $\mu = \frac{1}{\alpha}$ and $\nu = \alpha$. Then

$$f(a,b) = ab + ([1\mu] + \dots + [\mu]) + ([1\nu] + \dots + [\nu]).$$

They even suggested that this could be the source of a fun olympiad problem: it is not easy to see that f is a bijection.

• (On the choice of statement, by the proposer). As seen in the solution, such functions have various properties, and it was not clear what statement to choose.

I decided to go with the present statement since I believe it requires a good understanding of the setup and the functions involved. The key property is used in order to establish the bounds, and the formula is used to develop constructions and easily verify they work.

While choosing a different statement (e.g. just prove the key property) may make the problem less bulky, I believe that doing so runs the risk of introducing unintended solutions which don't "see the full picture." In fact, the present statement probably runs admits such solutions as well, likely through proving the key property via simply examining valid locations for n + 1 given the locations of $0, \ldots, n$, and using induction.

Unfortunately, I'm not sure how else to improve the statement.

One person I've shown this problem to suggests removing one half of the problem, by only asking for the smallest or only the largest possible value of N. Their rationale is that the two parts are mostly the same. I sympathize with them, but am reluctant to break the symmetry.

• (PSC) The real difficulty of this problem is that one should understand the whole picture, and in particular how the function f works, and how that quadrant can behave. In this solution we characterised all such functions f, before even talking about parity, while the problem only asks the number of odd numbers.

Geometry

Solution 1. By the conditions we have BC = DE, CT = ET and TB = TD, so the triangles TBC and TDE are congruent, in particular $\angle BTC = \angle DTE$.

In triangles TBQ and TES we have $\angle TBQ = \angle SET$ and $\angle QTB = 180^{\circ} - \angle BTC = 180^{\circ} - \angle DTE = \angle ETS$, so these triangles are similar to each other. It follows that $\angle TSE = \angle BQT$ and


$$\frac{TD}{TQ} = \frac{TB}{TQ} = \frac{TE}{TS} = \frac{TC}{TS}.$$

By rearranging this relation we get $TD \cdot TS = TC \cdot TQ$, so C, D, Q and S are concyclic. (Alternatively, we can get $\angle CQD = \angle CSD$ from the similar triangles TCS and TDQ.) Hence, $\angle DCQ = \angle DSQ$.

Finally, from the angles of triangle CQP we get

$$\angle RPQ = \angle RCQ - \angle PQC = \angle DSQ - \angle DSR = \angle RSQ,$$

which proves that P, Q, R and S are concyclic.



Solution 2. As in the previous solution, we note that triangles TBC and TDE are congruent. Denote the intersection point of DT and BA by V, and the intersection point of CT and EA by W. From triangles BCQ and DES we then have

$$\angle VSW = \angle DSE = 180^{\circ} - \angle SED - \angle EDS = 180^{\circ} - \angle AET - \angle TED - \angle EDT$$

$$= 180^{\circ} - \angle TBA - \angle TCB - \angle CBT = 180^{\circ} - \angle QCB - \angle CBQ = \angle BQC = \angle VQW,$$

meaning that VSQW is cyclic, and in particular $\angle WVQ = \angle WSQ$. Since

$$\angle VTB = 180^{\circ} - \angle BTC - \angle CTD = 180^{\circ} - \angle CTD - \angle DTE = \angle ETW$$

and $\angle TBV = \angle WET$ by assumption, we have that the triangles VTB and WTE are similar, hence

$$\frac{VT}{WT} = \frac{BT}{ET} = \frac{DT}{CT}.$$

Thus $CD \parallel VW,$ and angle chasing yields

$$\angle RPQ = \angle WVQ = \angle WSQ = \angle RSQ,$$

concluding the proof.

G2. In the acute-angled triangle ABC, the point F is the foot of the altitude from A, and P is a point on the segment AF. The lines through P parallel to AC and AB meet BC at D and E, respectively. Points $X \neq A$ and $Y \neq A$ lie on the circles ABD and ACE, respectively, such that DA = DX and EA = EY.

Prove that B, C, X and Y are concyclic.


(Netherlands)

Solution 1. Let A' be the intersection of lines BX and CY. By power of a point, it suffices to prove that $A'B \cdot A'X = A'C \cdot A'Y$, or, equivalently, that A' lies on the radical axis of the circles ABDX and ACEY.

From DA = DX it follows that in circle ABDX, point D bisects of one of the arcs AX. Therefore, depending on the order of points, the line BC is either the internal or external bisector of $\angle ABX$. In both cases, line BX is the reflection of BA in line BDC. Analogously, line CY is the reflection of CA in line BC; we can see that A' is the reflection of A in line BC, so A, F and A' are collinear.

By $PD \parallel AC$ and $PE \parallel AB$ we have $\frac{FD}{FC} = \frac{FP}{FA} = \frac{FE}{FB}$, hence $FD \cdot FB = FE \cdot FC$. So, point F has equal powers with respect to circles ABDX and ACEY.

Point A, being a common point of the two circles, is another point with equal powers, so the radical axis of circles ABDX and ACEY is the altitude AF that passes through A'.



Solution 2. We present another way to prove that line APA' is the radical axis of the circles ABD and ACE. It suffices to show that the second intersection point of ABD and ACE lies on AP.


Define N to be the second intersection of circle PDE and AP. From $\angle DNA = \angle DNP = \angle DEP = \angle DBA$ it follows that N lies on circle ABD; analogously, we can show that N lies on circle ACE.

G3. Let ABCD be a cyclic quadrilateral. Assume that the points Q, A, B, P are collinear in this order, in such a way that the line AC is tangent to the circle ADQ, and the line BD is tangent to the circle BCP. Let M and N be the midpoints of BC and AD, respectively. Prove that the following three lines are concurrent: line CD, the tangent of circle ANQ at point A, and the tangent to circle BMP at point B.

(Slovakia)

Solution 1. We first prove that triangles ADQ and CDB are similar. Since ABCD is cyclic, we have $\angle DAQ = \angle DCB$. By the tangency of AC to the circle AQD we also have $\angle CBD = \angle CAD = \angle AQD$. The claimed similarity is proven.

Let R be the midpoint of CD. Points N and R correspond in the proven similarity, and so $\angle QNA = \angle BRC$.




Let K be the second common point of line CD with circle ABR (i.e., if CD intersects circle ABR, then $K \neq R$ is the other intersection; otherwise, if CD is tangent to CD, then K = R). In both cases, we have $\angle BAK = \angle BRC = \angle QNA$; that indicates that AK is tangent to circle ANQ. It can be showed analogously that BK is tangent to circle BMP.

Comment. Note that M and N can be any points on lines BC and AD such that BM:MC=DN:NA, as we then simply choose R to be such that DR:RC is that same ratio, and the rest of the proof remains unchanged.

Solution 2. We present a second solution, without using the condition that ABCD is cyclic. Again, M and N can be any points on lines BC and AD such that BM : MC = DN : NA.

Let AB and CD meet at T (if $AB \parallel CD$ then T is their common ideal point). Let CD meet the tangent to the circle ANQ at A, and the tangent to the circle BMP at B at points K_1 and K_2 , respectively.



Let I and J be the ideal points of AD and BC, respectively. Notice that the pencils (AD, AC, AT, AK_1) and (QA, QD, QI, QN) of lines are congruent, because $\angle K_1AD = \angle AQN$, $\angle CAD = \angle AQD$ and $\angle IAT = \angle IQT$. Hence,

$$(D, C; T, K_1) = (AD, AC; AT, AK_1) = (QA, QD; QI, QN) = (A, D; I, N) = \frac{DN}{NA}.$$

It can be obtained analogously that

$$(D, C; T, K_2) = (BD, BC; BT, BK_2) = (PC, PB; PJ, PM) = (C, B; I, N) = \frac{BM}{MC}.$$

From BM: MC = DN: DA we get $(D, C; T, K_1) = (D, C; T, K_2)$ and hence $K_1 = K_2$.

G4. Let ABC be an acute-angled triangle with AC > AB, let O be its circumcentre, and let D be a point on the segment BC. The line through D perpendicular to BC intersects the lines AO, AC and AB at W, X and Y, respectively. The circumcircles of triangles AXY and ABC intersect again at $Z \neq A$.

Prove that if OW = OD, then DZ is tangent to the circle AXY.


(United Kingdom)

Solution 1. Let AO intersect BC at E. As EDW is a right-angled triangle and O is on WE, the condition OW = OD means O is the circumcentre of this triangle. So OD = OE which establishes that D, E are reflections in the perpendicular bisector of BC.

Now observe:

$$180^{\circ} - \angle DXZ = \angle ZXY = \angle ZAY = \angle ZCD$$
,

which shows CDXZ is cyclic.



We next show that $AZ \parallel BC$. To do this, introduce point Z' on circle ABC such that $AZ' \parallel BC$. By the previous result, it suffices to prove that CDXZ' is cyclic. Notice that triangles BAE and CZ'D are reflections in the perpendicular bisector of BC. Using this and that A, O, E are collinear:

$$\angle DZ'C = \angle BAE = \angle BAO = 90^{\circ} - \frac{1}{2}\angle AOB = 90^{\circ} - \angle C = \angle DXC$$

so DXZ'C is cyclic, giving $Z \equiv Z'$ as desired.


Using $AZ \parallel BC$ and CDXZ cyclic we get:

$$\angle AZD = \angle CDZ = \angle CXZ = \angle AYZ$$
,

which by the converse of alternate segment theorem shows DZ is tangent to circle AXY.

Solution 2. Notice that point Z is the Miquel-point of lines AC, BC, BA and DY; then B, D, Z, Y and C, D, X, Y are concyclic. Moreover, Z is the centre of the spiral similarity that maps BC to YX.

By $BC \perp YX$, the angle of that similarity is 90°; hence the circles ABCZ and AXYZ are perpendicular, therefore the radius OZ in circle ABCZ is tangent to circle AXYZ.



By OW = OD, the triangle OWD is isosceles, and

$$\angle ZOA = 2\angle ZBA = 2\angle ZBY = 2\angle ZDY = \angle ODW + \angle DWO$$
,

so D lies on line ZO that is tangent to circle AXY.

G5. Let ABC be a triangle, and let ℓ_1 and ℓ_2 be two parallel lines. For i = 1, 2, let ℓ_i meet the lines BC, CA, and AB at X_i , Y_i , and Z_i , respectively. Suppose that the line through X_i perpendicular to BC, the line through Y_i perpendicular to CA, and finally the line through Z_i perpendicular to AB, determine a non-degenerate triangle Δ_i .


Show that the circumcircles of Δ_1 and Δ_2 are tangent to each other.

(Vietnam)

Solution 1. Throughout the solutions, $\neq (p, q)$ will denote the directed angle between lines p and q, taken modulo 180° .

Let the vertices of Δ_i be D_i , E_i , F_i , such that lines E_iF_i , F_iD_i and D_iE_i are the perpendiculars through X, Y and Z, respectively, and denote the circumcircle of Δ_i by ω_i .

In triangles $D_1Y_1Z_1$ and $D_2Y_2Z_2$ we have $Y_1Z_1 \parallel Y_2Z_2$ because they are parts of ℓ_1 and ℓ_2 . Moreover, $D_1Y_1 \parallel D_2Y_2$ are perpendicular to AC and $D_1Z_1 \parallel D_2Z_2$ are perpendicular to AB, so the two triangles are homothetic and their homothetic centre is $Y_1Y_2 \cap Z_1Z_2 = A$. Hence, line D_1D_2 passes through A. Analogously, line E_1E_2 passes through B and F_1F_2 passes through C.



The corresponding sides of Δ_1 and Δ_2 are parallel, because they are perpendicular to the respective sides of triangle ABC. Hence, Δ_1 and Δ_2 are either homothetic, or they can be translated to each other. Using that B, X_2 , Z_2 and E_2 are concyclic, C, X_2 , Y_2 and F_2 are concyclic, $Z_2E_2 \perp AB$ and Y_2 , $F_2 \perp AC$ we can calculate

and conclude that lines E_1E_2 and F_1F_2 are not parallel. Hence, Δ_1 and Δ_2 are homothetic; the lines D_1D_2 , E_1E_2 , and F_1F_2 are concurrent at the homothetic centre of the two triangles. Denote this homothetic centre by H.

For i = 1, 2, using (1), and that A, Y_i, Z_i and D_i are concyclic,


so H lies on circle ω_i .

The same homothety that maps Δ_1 to Δ_2 , sends ω_1 to ω_2 as well. Point H, that is the centre of the homothety, is a common point of the two circles, That finishes proving that ω_1 and ω_2 are tangent to each other.

Solution 2. As in the first solution, let the vertices of Δ_i be D_i , E_i , F_i , such that E_iF_i , F_iD_i and D_iE_i are the perpendiculars through X_i , Y_i and Z_i , respectively. In the same way we conclude that (A, D_1, D_2) , (B, E_1, E_2) and (C, F_1, F_2) are collinear.

The corresponding sides of triangles ABC and $D_iE_iF_i$ are perpendicular to each other. Hence, there is a spiral similarity with rotation $\pm 90^{\circ}$ that maps ABC to $D_iE_iF_i$; let M_i be the centre of that similarity. Hence, $\not< (M_iA, M_iD_i) = \not< (M_iB, M_iE_i) = \not< (M_iC, M_iF_i) = 90^{\circ}$. The circle with diameter AD_i passes through M_i, Y_i, Z_i , so M_i, A, Y_i, Z_i , D_i are concyclic; analogously (M_i, B, X_i, Z_i, E_i) and (M_i, C, X_i, Y_i, F_i) are concyclic.

By applying Desargues' theorem to triangles ABC and $D_iE_iF_i$ we conclude that the lines AD_i , BE_i and BF_i are concurrent; let their intersection be H. Since $(A, D_1.D_2)$, $(B, E_1.E_2)$ and $(C, F_1.F_2)$ are collinear, we obtain the same point H for i = 1 and i = 2.



By $\not\prec (CB, CH) = \not\prec (CX_i, CF_i) = \not\prec (Y_iX_i, Y_iF_i) = \not\prec (Y_iZ_i, Y_iD_i) = \not\prec (AZ_i, AD_i) = \not\prec (AB, AH)$, point H lies on circle ABC.

Analogously, from $\not\prec (F_iD_i, F_iH) = \not\prec (F_iY_i, F_iC) = \not\prec (X_iY_i, X_iC) = \not\prec (X_iZ_i, X_iB) = \not\prec (E_iZ_i, E_iB) = \not\prec (E_iD_i, E_iH)$, we can see that point H lies on circle $D_iE_iF_i$ as well. Therefore, circles ABC and $D_iE_iF_i$ intersect at point H.

The spiral similarity moves the circle ABC to circle $D_iE_iF_i$, so the two circles are perpendicular. Hence, both circles $D_1E_1F_1$ and $D_2E_2F_2$ are tangent to the radius of circle ABC at H.

Comment 1. As the last picture suggests, the circles ABC and $D_iE_iF_i$ pass through M_i . In fact, point M_i , being the second intersection of circles $D_iE_iF_i$ and $D_iY_iZ_i$, the Miquel point of the lines AY_i , AZ_i , CX_i and X_iY_i , so it is concyclic with A, B, C. Similarly, M_i the Miquel point of lines D_iE_i , E_iF_i , F_iY_i and X_iY_i , so it is concyclic with D_i , E_i , D_i .


Comment 2. Instead of two lines ℓ_1 and ℓ_2 , it is possible to reformulate the problem with a single, varying line ℓ :

Let ABC be a triangle, and let ℓ be a varying line whose direction is fixed. Let ℓ intersect lines BC, CA, and AB at X, Y, and Z, respectively. Suppose that the line through X, perpendicular to BC, the line through Y, perpendicular to CA, and the line through Z, perpendicular to AB, determine a non-degenerate triangle Δ .

Show that as ℓ varies, the circumcircles of the obtained triangles Δ pass through a fixed point, and these circles are tangent to each other.

A reasonable approach is finding the position of line ℓ when the triangle DEF degenerates to a single point. That happens when the line XYZ is the Simson line respect to point D=E=F on the circumcircle ABC. Based on this observation a possible variant of the solution is as follows.

Let H be the second intersection of circles ABC and line AD. Like in the solutions above, we can find that the line AD is fixed, so H is independent of the position of line ℓ .



From $\not\prec (HF, HD) = \not\prec (HC, HA) = \not\prec (BC, BA) = \not\prec (BX, BZ) = \not\prec (EX, EZ) = \not\prec (EF, ED)$ we can see that circle Δ passes through H. Hence, all circles DEF passes through a fixed point.

The corresponding sides of triangles ABC and DEF are perpendicular, so their circumcircle are perpendicular; that proves that circle DEF is tangent to the radius of circle ABC at H.


G6. In an acute-angled triangle ABC, point H is the foot of the altitude from A. Let P be a moving point such that the bisectors k and ℓ of angles PBC and PCB, respectively, intersect each other on the line segment AH. Let k and AC meet at E, let ℓ and AB meet at E, and let EF and E and E meet at E and E point.

(Iran)

Solution 1. Let the reflections of the line BC with respect to the lines AB and AC intersect at point K. We will prove that P, Q and K are collinear, so K is the common point of the varying line PQ.

Let lines BE and CF intersect at I. For every point O and d > 0, denote by (O, d) the circle centred at O with radius d, and define $\omega_I = (I, IH)$ and $\omega_A = (A, AH)$. Let ω_K and ω_P be the incircle of triangle KBC and the P-excircle of triangle PBC, respectively.

Since $IH \perp BC$ and $AH \perp BC$, the circles ω_A and ω_I are tangent to each other at H. So, H is the external homothetic centre of ω_A and ω_I . From the complete quadrangle BCEF we have (A, I; Q, H) = -1, therefore Q is the internal homothetic centre of ω_A and ω_I . Since BA and CA are the external bisectors of angles $\angle KBC$ and $\angle KCB$, circle ω_A is the K-excircle in triangle BKC. Hence, K is the external homothetic centre of ω_A and ω_K . Also it is clear that P is the external homothetic centre of ω_I and ω_P . Let point T be the tangency point of ω_P and BC, and let T' be the tangency point of ω_K and BC. Since ω_I is the incircle and ω_P is the P-excircle of PBC, TC = BH and since ω_K is the incircle and ω_A is the K-excircle of KBC, T'C = BH. Therefore TC = T'C and $T \equiv T'$. It yields that ω_K and ω_P are tangent to each other at T.



Let point S be the internal homothetic centre of ω_A and ω_P , and let S' be the internal homothetic centre of ω_I and ω_K . It's obvious that S and S' lie on BC. We claim that $S \equiv S'$. To prove our claim, let r_A , r_I , r_P , and r_K be the radii of ω_A , ω_I , ω_P and ω_K , respectively.

It is well known that if the sides of a triangle are a, b, c, its semiperimeter is s = (a+b+c)/2, and the radii of the incircle and the a-excircle are r and r_a , respectively, then $r \cdot r_a = (s-b)(s-c)$. Applying this fact to triangle PBC we get $r_I \cdot r_P = BH \cdot CH$. The same fact in triangle KCB

side, AM is also tangent to \mathcal{H} at K.


yields $r_K \cdot r_A = CT \cdot BT$. Since BH = CT and BT = CH, from these two we get

$$\frac{HS}{ST} = \frac{r_A}{r_P} = \frac{r_I}{r_K} = \frac{HS'}{S'T},$$

so S = S' indeed.

Finally, by applying the generalised Monge's theorem to the circles ω_A , ω_I , and ω_K (with two pairs of internal and one pair of external common tangents), we can see that points Q, S, and K are collinear. Similarly one can show that Q, S and P are collinear, and the result follows.

Solution 2. Again, let BE and CF meet at I, that is the incentre in triangle BCP; then PI is the third angle bisector. From the tangent segments of the incircle we have BP - CP = BH - CH; hence, the possible points P lie on a branch of a hyperbola \mathcal{H} with foci B, C, and B is a vertex of B. Since B bisects the angle between the radii BP and B of the hyperbola, line B is tangent to B.



Let K be the second intersection of PQ and \mathcal{H} , we will show that AK is tangent to \mathcal{H} at K; this property determines K.

Let $G = KI \cap AP$ and $M = PI \cap AK$. From the complete quadrangle BCEF we can see that (H, Q; I, A) is harmonic, so in the complete quadrangle APIK, point H lies on line GM. Consider triangle AIM. Its side AI is tangent to \mathcal{H} at H, the side IM is tangent to \mathcal{H} at P, and K is a common point of the third side AM and the hyperbola such that the lines AP, IK and MH are concurrent at the generalised Gergonne-point G. It follows that the third


(Alternatively, in the last step we can apply the converse of Brianchon's theorem to the degenerate hexagon AHIPMK. By the theorem there is a conic section \mathcal{H}' such that lines AI, IM and MA are tangent to \mathcal{H}' at H, P and K, respectively. But the three points H, K and P, together with the tangents at H and P uniquely determine \mathcal{H}' , so indeed $\mathcal{H}' = \mathcal{H}$.)

G7. Let ABC and A'B'C' be two triangles having the same circumcircle ω , and the same orthocentre H. Let Ω be the circumcircle of the triangle determined by the lines AA', BB' and CC'. Prove that H, the centre of ω , and the centre of Ω are collinear.

(Denmark)

Solution. In what follows, $\not<(p,q)$ will denote the directed angle between lines p and q, taken modulo 180°. Denote by O the centre of ω . In any triangle, the homothety with ratio $-\frac{1}{2}$ centred at the centroid of the triangle takes the vertices to the midpoints of the opposite sides and it takes the orthocentre to the circumcentre. Therefore the triangles ABC and A'B'C' share the same centroid G and the midpoints of their sides lie on a circle ρ with centre on OH. We will prove that ω , Ω , and ρ are coaxial, so in particular it follows that their centres are collinear on OH.

Let $D = BB' \cap CC'$, $E = CC' \cap AA'$, $F = AA' \cap BB'$, $S = BC' \cap B'C$, and $T = BC \cap B'C'$. Since D, S, and T are the intersections of opposite sides and of the diagonals in the quadrilateral BB'CC' inscribed in ω , by Brocard's theorem triangle DST is self-polar with respect to ω , i.e. each vertex is the pole of the opposite side. We apply this in two ways.



First, from D being the pole of ST it follows that the inverse D^* of D with respect to ω is the projection of D onto ST. In particular, D^* lies on the circle with diameter SD. If N denotes the midpoint of SD and R the radius of ω , then the power of O with respect to this circle is $ON^2 - ND^2 = OD \cdot OD^* = R^2$. By rearranging, we see that ND^2 is the power of N with respect to ω .

Second, from T being the pole of SD it follows that OT is perpendicular to SD. Let M and M' denote the midpoints of BC and B'C'. Then since $OM \perp BC$ and $OM' \perp B'C'$ it follows that OMM'T is cyclic and

$$\not \preceq (SD, BC) = \not \preceq (OT, OM) = \not \preceq (B'C', MM').$$

From BB'CC' being cyclic we also have $\not\prec (BC, BB') = \not\prec (CC', B'C')$, hence we obtain

$$\stackrel{\checkmark}{\times}(SD,BB') = \stackrel{\checkmark}{\times}(SD,BC) + \stackrel{\checkmark}{\times}(BC,BB')
= \stackrel{\checkmark}{\times}(B'C',MM') + \stackrel{\checkmark}{\times}(CC',B'C') = \stackrel{\checkmark}{\times}(CC',MM').$$

Now from the homothety mentioned in the beginning, we know that MM' is parallel to AA', hence the above implies that $\angle(SD, BB') = \angle(CC', AA')$, which shows that Ω is tangent to SD at D. In particular, ND^2 is also the power of N with respect to Ω .

Additionally, from BB'CC' being cyclic it follows that triangles DBC and DC'B' are inversely similar, so $\angle (BB', DM') = \angle (DM, CC')$. This yields


$$\stackrel{\checkmark}{\times} (SD, DM') = \stackrel{\checkmark}{\times} (SD, BB') + \stackrel{\checkmark}{\times} (BB', DM')
= \stackrel{\checkmark}{\times} (CC', MM') + \stackrel{\checkmark}{\times} (DM, CC') = \stackrel{\checkmark}{\times} (DM, MM'),$$

which shows that the circle DMM' is also tangent to SD. Since N, M, and M' are collinear on the Newton–Gauss line of the complete quadrilateral determined by the lines BB', CC', BC', and B'C, it follows that $ND^2 = NM \cdot NM'$. Hence N has the same power with respect to ω , Ω , and ρ .

By the same arguments there exist points on the tangents to Ω at E and F which have the same power with respect to ω , Ω , and ρ . The tangents to a given circle at three distinct points cannot be concurrent, hence we obtain at least two distinct points with the same power with respect to ω , Ω , and ρ . Hence the three circles are coaxial, as desired.

Comment 1. Instead of invoking the Newton–Gauss line, one can also use a nice symmetry argument: If from the beginning we swapped the labels of B' and C', then in the proof above the labels of D and S would be swapped while the labels of M and M' do not change. The consequence is that the circle SMM' is also tangent to SD. Since N is the midpoint of SD it then has the same power with respect to circles DMM' and SMM', so it lies on their radical axis MM'.

Comment 2. There exists another triple of points on the common radical axis of ω , Ω , and ρ which can be used to solve the problem. We outline one such solution.



Let L and L' denote the feet of the altitudes from A and A' in triangle ABC and A'B'C', respectively. Since ρ is the nine-point circle of the two triangles it contains both L and L'. Furthermore, $HA \cdot HL$ and $HA' \cdot HL'$ both equal twice the power of H with respect to ρ , so A, A', L, L' are concyclic as well.

Now let $\ell = AA'$ and denote $P = LL' \cap \ell$, $K = BC \cap \ell$, and $K' = B'C' \cap \ell$. As $MM' \parallel \ell$ (shown in the previous solution) and LL'MM' is cyclic

$$\not \preceq (BC, \ell) = \not \preceq (BC, MM') = \not \preceq (LL', B'C')$$

so K, K', L, and L' are also concyclic. From the cyclic quadrilaterals AA'LL' and KK'LL' we get $PA \cdot PA' = PL \cdot PL' = PK \cdot PK'$. This implies that P is the centre of the (unique) involution σ on ℓ that swaps A, A' and K, K'. On the other hand, by Desargues' involution theorem applied to the line ℓ , the quadrilateral BB'CC', and its circumcircle ω , the involution σ also swaps E and F. Hence

$$PA \cdot PA' = PL \cdot PL' = PE \cdot PF$$


However, this means that P has the same power with respect to ω , Ω , and ρ , and by the same arguments there exist points on BB' and CC' with this property.

G8. Let AA'BCC'B' be a convex cyclic hexagon such that AC is tangent to the incircle of the triangle A'B'C', and A'C' is tangent to the incircle of the triangle ABC. Let the lines AB and A'B' meet at X and let the lines BC and B'C' meet at Y.

Prove that if XBYB' is a convex quadrilateral, then it has an incircle.

(Australia)


Solution. Denote by ω and ω' the incircles of $\triangle ABC$ and $\triangle A'B'C'$ and let I and I' be the centres of these circles. Let N and N' be the second intersections of BI and B'I' with Ω , the circumcircle of A'BCC'B'A, and let O be the centre of Ω . Note that $ON \perp AC$, $ON' \perp A'C'$ and ON = ON' so NN' is parallel to the angle bisector II' of AC and A'C'. Thus $II' \parallel NN'$ which is antiparallel to BB' with respect to BI and B'I'. Therefore B, I, I', B' are concyclic.




Further define P as the intersection of AC and A'C' and M as the antipode of N' in Ω . Consider the circle Γ_1 with centre N and radius NA = NC and the circle Γ_2 with centre M and radius MA' = MC'. Their radical axis passes through P and is perpendicular to $MN \perp NN' \parallel IP$, so I lies on their radical axis. Therefore, since I lies on Γ_1 , it must also lie on Γ_2 . Thus, if we define Z as the second intersection of MI with Ω , we have that I is the incentre of triangle ZA'C'. (Note that the point Z can also be constructed directly via Poncelet's porism.)

Consider the incircle ω_c with centre I_c of triangle C'B'Z. Note that $\angle ZIC' = 90^{\circ} + \frac{1}{2}\angle ZA'C' = 90^{\circ} + \frac{1}{2}\angle ZB'C' = \angle ZI_cC'$, so Z, I, I_c , C' are concyclic. Similarly B', I', I_c , C' are concyclic.

The external centre of dilation from ω to ω_c is the intersection of II_c and C'Z (D in the picture), that is the radical centre of circles Ω , $C'I_cIZ$ and $II'I_c$. Similarly, the external centre of dilation from ω' to ω_c is the intersection of $I'I_c$ and B'C' (D' in the picture), that is the radical centre of circles Ω , $B'I'I_cC'$ and $II'I_c$. Therefore the Monge line of ω , ω' and ω_c is line DD', and the radical axis of Ω and circle $II'I_c$ coincide. Hence the external centre T of dilation from ω to ω' is also on the radical axis of Ω and circle $II'I_c$.



Now since B, I, I', B' are concyclic, the intersection T' of BB' and II' is on the radical axis of Ω and circle $II'I_c$. Thus T' = T and T lies on line BB'. Finally, construct a circle Ω_0 tangent to A'B', B'C', AB on the same side of these lines as ω' . The centre of dilation from ω' to Ω_0 is B', so by Monge's theorem the external centre of dilation from Ω_0 to ω must be on the line TBB'. However, it is on line AB, so it must be B and BC must be tangent to Ω_0 as desired.



Number Theory

N1. A number is called *Norwegian* if it has three distinct positive divisors whose sum is equal to 2022. Determine the smallest Norwegian number.

(Note: The total number of positive divisors of a Norwegian number is allowed to be larger than 3.)

(Cyprus)

Answer: 1344

Solution. Observe that 1344 is a Norwegian number as 6, 672 and 1344 are three distinct divisors of 1344 and 6 + 672 + 1344 = 2022. It remains to show that this is the smallest such number.

Assume for contradiction that N < 1344 is Norwegian and let N/a, N/b and N/c be the three distinct divisors of N, with a < b < c. Then

$$2022 = N\left(\frac{1}{a} + \frac{1}{b} + \frac{1}{c}\right) < 1344\left(\frac{1}{a} + \frac{1}{b} + \frac{1}{c}\right)$$

and so

$$\left(\frac{1}{a} + \frac{1}{b} + \frac{1}{c}\right) > \frac{2022}{1344} = \frac{337}{224} = \frac{3}{2} + \frac{1}{224}.$$

If a > 1 then

$$\frac{1}{a} + \frac{1}{b} + \frac{1}{c} \leqslant \frac{1}{2} + \frac{1}{3} + \frac{1}{4} = \frac{13}{12} < \frac{3}{2},$$

so it must be the case that a = 1. Similarly, it must hold that b < 4 since otherwise

$$1 + \frac{1}{b} + \frac{1}{c} \le 1 + \frac{1}{4} + \frac{1}{5} < \frac{3}{2}$$
.

This leaves two cases to check, b = 2 and b = 3.

Case b = 3. Then

$$\frac{1}{c} > \frac{3}{2} + \frac{1}{224} - 1 - \frac{1}{3} > \frac{1}{6}$$

so c = 4 or c = 5. If c = 4 then

$$2022 = N\left(1 + \frac{1}{3} + \frac{1}{4}\right) = \frac{19}{12}N,$$

but this is impossible as $19 \nmid 2022$. If c = 5 then

$$2022 = N\left(1 + \frac{1}{3} + \frac{1}{5}\right) = \frac{23}{15}N,$$

which again is impossible, as $23 \nmid 2022$.

Case b = 2. Note that c < 224 since

$$\frac{1}{c} > \frac{3}{2} + \frac{1}{224} - 1 - \frac{1}{2} = \frac{1}{224}.$$

It holds that

$$2022 = N\left(1 + \frac{1}{2} + \frac{1}{c}\right) = \frac{3c+2}{2c}N \Rightarrow (3c+2)N = 4044c.$$

Since $(c, 3c-2) = (c, 2) \in \{1, 2\}$, then $3c+2 \mid 8088 = 2^3 \cdot 3 \cdot 337$ which implies that $3c+2 \mid 2^3 \cdot 337$. But since $3c+2 \ge 3 \cdot 3 + 2 > 8 = 2^3$ and $3c+2 \ne 337$, then it must hold that $3c+2 \ge 2 \cdot 337$, contradicting c < 224.

N2.

Find all positive integers n > 2 such that

$$n! \mid \prod_{\substack{p < q \leqslant n, \\ p, q \text{ primes}}} (p+q).$$

(Nigeria)

Answer: This only holds for n = 7.

Solution. Assume that n satisfies $n! | \prod_{p < q \le n} (p+q)$ and let $2 = p_1 < p_2 < \cdots < p_m \le n$ be the primes in $\{1, 2, \ldots, n\}$. Each such prime divides n!. In particular, $p_m | p_i + p_j$ for some $p_i < p_j \le n$. But

$$0 < \frac{p_i + p_j}{p_m} < \frac{p_m + p_m}{p_m} = 2,$$

so $p_m = p_i + p_j$ which implies $m \ge 3$, $p_i = 2$ and $p_m = 2 + p_j = 2 + p_{m-1}$. Similarly, $p_{m-1}|p_k + p_l$ for some $p_k < p_l \le n$. But

$$0 < \frac{p_l + p_k}{p_{m-1}} \le \frac{p_m + p_{m-1}}{p_{m-1}} = \frac{2p_{m-1} + 2}{p_{m-1}} < 3,$$

so either $p_{m-1} = p_l + p_k$ or $2p_{m-1} = p_l + p_k$. As above, the former case gives $p_{m-1} = 2 + p_{m-2}$. If $2p_{m-1} = p_l + p_k$, then $p_{m-1} < p_k$, so k = m and

$$2p_{m-1} = p_l + p_{m-1} + 2 \Rightarrow p_{m-1} = p_l + 2 = p_{m-2} + 2.$$

Either way, $p_{m-2} > 2$ and 3 divides one of p_{m-2} , $p_{m-1} = p_{m-2} + 2$ and $p_m = p_{m-2} + 4$. This implies $p_{m-2} = 3$ and thus $p_m = 7$, giving $7 \le n < 11$.

Finally, a quick computation shows that $7! \mid \prod_{p < q \le 7} (p+q)$ but $8! \nmid \prod_{p < q \le 7} (p+q)$, so neither does 9! and 10!.

N3. Let a > 1 be a positive integer, and let d > 1 be a positive integer coprime to a. Let $x_1 = 1$ and, for $k \ge 1$, define

$$x_{k+1} = \begin{cases} x_k + d & \text{if } a \text{ doesn't divide } x_k, \\ x_k/a & \text{if } a \text{ divides } x_k. \end{cases}$$

Find the greatest positive integer n for which there exists an index k such that x_k is divisible by a^n .

(Croatia)

Answer: n is the exponent with $d < a^n < ad$.

Solution 1. By trivial induction, x_k is coprime to d.

By induction and the fact that there can be at most a-1 consecutive increasing terms in the sequence, it also holds that $x_k < da$ if $x_k = x_{k-1} + d$ and that $x_k < d$ if $x_k = \frac{x_{k-1}}{a}$ or k = 1. This gives the upper bound on the exponent.

This implies that the sequence is (eventually) periodic, and that both increasing and decreasing steps happen infinitely many times. Let a^{-k} be the multiplicative inverse of a^k modulo d. The sequence contains elements congruent to $1, a^{-1}, a^{-2}, \ldots$ modulo d.

Let x_{k_0} the first element such that $x_{k_0} \equiv a^{-n} \pmod{d}$. We have either $k_0 = 1$ or $x_{k_0} = x_{k_0-1}/a$; in both cases $x_{k_0} < d < a^n < da$ and therefore

$$x_{k_0} \in \{a^n - d, a^n - 2d, \dots, a^n - (a-1)d\}.$$

In this set no element is divisible by a, so therefore the sequence will visit the value a^n in the next a-1 steps.

Solution 2. Like in the first solution, x_k is relatively prime to d and $x_k < ad$ for all k. Let

$$S = \{x \in \mathbb{Z}_{>0} : 0 < x < ad, \ \gcd(x, d) = 1\} \quad \text{and} \quad f : S \to S, \ f(x) = \begin{cases} x + d & \text{if } a \nmid x, \\ x/a & \text{if } a \mid x. \end{cases}$$

So, we have $x_1 = 1$ and $x_{k+1} = f(x_k)$.

Notice that the recurrence formula is invertible. Suppose that f(x) = y for some $x, y \in S$. If y > d then $y - d \in S$ but $a \cdot y \notin S$; otherwise, if y < d then $a \cdot y \in S$ but $y - d \notin S$. So, the function f is a permutation on S, and its inverse is

$$f^{-1}(y) = \begin{cases} y - d & \text{if } y > d, \\ a \cdot y & \text{if } y < d \end{cases} \text{ for all } y \in S.$$

It follows that the sequence is periodic, and therefore attains the initial value 1 infinitely many times. Let $k_1 > 1$ be an index such that $x_{k_1} = 1$. Then

$$x_{k_1} = 1$$
, $x_{k_1-1} = f^{-1}(1) = a$, $x_{k_1-2} = f^{-1}(a) = a^2$, ..., $x_{k_1-n} = a^n$.

Solution 3. Like in the first solution, x_k is relatively prime to d and $x_k < ad$ for all k.

We wish to prove that there are n consecutive decreasing indices. Let $m_0 = 0$ and m_k be the k-th smallest decreasing index (an index k is decreasing if $x_k = x_{k-1}/a$) and define a sequence $(y_k)_k = (x_{m_k})_k$, i.e. the subsequence consisting only of elements with decreasing indices. For each $k \ge 1$ we can write

$$y_{k+1} = \frac{y_k + z_k d}{a}$$

for some $z_k \in \{0, 1, \dots, a-1\}$, where $z_k = 0$ if and only if y_k and y_{k+1} are consecutive elements in the original sequence. Then

$$y_k = \frac{1 + (z_0 + z_1 a + \dots + z_{k-1} a^{k-1})d}{a^k},$$

because y_k is bounded the sequence is (eventually) periodic. Consider some $y_u = y_{u+v}$ where $v \ge 1$. We can write

$$y_u = \frac{1 + (z_0 + z_1 a + \dots + z_{u-1} a^{u-1})d}{a^u}$$

and

$$y_{u+v} = \frac{1 + (z_0 + z_1 a + \dots + z_{u+v-1} a^{u+v-1})d}{a^{u+v}}$$

and so

$$\frac{1 + (z_0 + z_1 a + \dots + z_{u+v-1} a^{u+v-1})d}{a^{u+v}} = \frac{1 + (z_0 + z_1 a + \dots + z_{u-1} a^{u-1})d}{a^u}.$$

Rearranging gives

$$\frac{a^{v}-1}{d}=z_{0}+z_{1}a+\cdots+z_{v-1}a^{v-1}+(z_{v}-z_{0})a^{v}+\cdots+(z_{u+v-1}-z_{u-1})a^{u+v-1}.$$

Since $d > a^n/a = a^{n-1}$ the LHS is strictly less than a^{v-n} . This implies that on the RHS, the coefficients of $a^{v-n}, a^{v-n+1}, \ldots$ must all be zero, i.e. $z_{v-n} = z_{v-n+1} = \cdots = z_{v-1} = 0$. This implies that there are n consecutive decreasing indices in the original sequence.

N4.

Find all triples of positive integers (a, b, p) with p prime and

$$a^p = b! + p.$$

(Belgium)

Answer: (2, 2, 2) and (3, 4, 3).

Solution 1. Clearly, a > 1. We consider three cases.

Case 1: We have a < p. Then we either have $a \le b$ which implies $a \mid a^p - b! = p$ leading to a contradiction, or a > b which is also impossible since in this case we have $b! \le a! < a^p - p$, where the last inequality is true for any p > a > 1.

Case 2: We have a > p. In this case $b! = a^p - p > p^p - p \ge p!$ so b > p which means that $a^p = b! + p$ is divisible by p. Hence, a is divisible by p and $b! = a^p - p$ is not divisible by p^2 . This means that b < 2p. If $a < p^2$ then a/p < p divides both a^p and b! and hence it also divides $p = a^p - b!$ which is impossible. On the other hand, the case $a \ge p^2$ is also impossible since then $a^p \ge (p^2)^p > (2p-1)! + p \ge b! + p$.

Comment. The inequality $p^{2p} > (2p-1)! + p$ can be shown e.g. by using

$$(2p-1)! = [1 \cdot (2p-1)] \cdot [2 \cdot (2p-2)] \cdot \dots \cdot [(p-1)(p+1)] \cdot p < \left(\left(\frac{2p}{2}\right)^2\right)^{p-1} \cdot p = p^{2p-1},$$

where the inequality comes from applying AM-GM to each of the terms in square brackets.

Case 3: We have a = p. In this case $b! = p^p - p$. One can check that the values p = 2, 3 lead to the claimed solutions and p = 5 does not lead to a solution. So we now assume that $p \ge 7$. We have $b! = p^p - p > p!$ and so $b \ge p + 1$ which implies that

$$v_2((p+1)!) \le v_2(b!) = v_2(p^{p-1}-1) \stackrel{LTE}{=} 2v_2(p-1) + v_2(p+1) - 1 = v_2\left(\frac{p-1}{2}\cdot(p-1)\cdot(p+1)\right),$$

where in the middle we used lifting-the-exponent lemma. On the RHS we have three factors of (p+1)!. But, due to $p+1 \ge 8$, there are at least 4 even numbers among $1, 2, \ldots, p+1$, so this case is not possible.

Solution 2. The cases $a \neq p$ are covered as in solution 1, as are p = 2, 3. For $p \geq 5$ we have $b! = p(p^{p-1} - 1)$. By Zsigmondy's Theorem there exists some prime q that divides $p^{p-1} - 1$ but does not divide $p^k - 1$ for $k . It follows that <math>\operatorname{ord}_q(p) = p - 1$, and hence $q \equiv 1 \mod (p-1)$. Note that $p \neq q$. But then we must have $q \geq 2p - 1$, giving

$$b! \geqslant (2p-1)! = [1 \cdot (2p-1)] \cdot [2 \cdot (2p-2)] \cdot \dots \cdot [(p-1) \cdot (p+1)] \cdot p > (2p-1)^{p-1}p > p^p > p^p - p,$$

a contradiction.

Solution 3. The cases $a \neq p$ are covered as in solution 1, as are p = 2, 3. Also b > p, as $p^p > p! + p$ for p > 2. The cases p = 5, 7, 11 are also checked manually, so assume $p \ge 13$. Let q|p+1 be an odd prime. By LTE

$$v_q(p^p - p) = v_q\left((p^2)^{\frac{p-1}{2}} - 1\right) = v_q(p^2 - 1) + v_q\left(\frac{p-1}{2}\right) = v_q(p+1).$$

But $b \ge p+1$, so then $v_q(b!) > v_q(p+1)$, since q < p+1, a contradiction. This means that p+1 has no odd prime divisor, i.e. $p+1=2^k$ for some k.

Now let q|p-1 be an odd prime. By LTE

$$v_q(p^p - p) = 2v_q(p - 1).$$

Let $d = v_q(p-1)$. Then $p \ge 1 + q^d$, so

$$v_q(b!) \geqslant v_q(p!) \geqslant v_q(q^d!) > q^{d-1} \geqslant 2d$$

provided $d \ge 2$ and q > 3, or $d \ge 3$.

If q = 3, d = 2 and $p \ge 13$ then $v_q(b!) \ge v_q(p!) \ge v_q(13!) = 5 > 2d$. Either way, $d \le 1$. If p > 2q + 1 (so p > 3q, as q|p - 1) then

$$v_q(b!) \geqslant v_q((3q)!) = 3,$$

so we must have $q \ge \frac{p}{2}$, in other words, p-1=2q. This implies that $p=2^k-1$ and $q=2^{k-1}-1$ are both prime, but it is not possible to have two consecutive Mersenne primes.

Solution 4. Let a = p, b > p and $p \ge 5$ (the remaining cases are dealt with as in solution 3). Modulo $(p + 1)^2$ it holds that

$$p^p - p = (p+1-1)^p - p \equiv \binom{p}{1}(p+1)(-1)^{p-1} + (-1)^p - p = p(p+1) - 1 - p = p^2 - 1 \not\equiv 0 \mod \left((p+1)^2\right).$$

Since $p \ge 5$, the numbers 2 and $\frac{p+1}{2}$ are distinct and less than or equal to p. Therefore, p+1|p!, and so $(p+1)^2|(p+1)!$.

But $b \ge p+1$, so $b! \equiv 0 \not\equiv p^p-p \mod (p+1)^2$, a contradiction.

N5. For each $1 \le i \le 9$ and $T \in \mathbb{N}$, define $d_i(T)$ to be the total number of times the digit i appears when all the multiples of 1829 between 1 and T inclusive are written out in base 10.

Show that there are infinitely many $T \in \mathbb{N}$ such that there are precisely two distinct values among $d_1(T), d_2(T), \ldots, d_9(T)$.

(United Kingdom)

Solution. Let n := 1829. First, we choose some k such that $n \mid 10^k - 1$. For instance, any multiple of $\varphi(n)$ would work since n is coprime to 10. We will show that either $T = 10^k - 1$ or $T = 10^k - 2$ has the desired property, which completes the proof since k can be taken to be arbitrary large.

For this it suffices to show that $\#\{d_i(10^k-1):1\leq i\leq 9\}\leq 2$. Indeed, if

$$\#\{d_i\left(10^k - 1\right) : 1 \leqslant i \leqslant 9\} = 1$$

then, since $10^k - 1$ which consists of all nines is a multiple of n, we have

$$d_i(10^k - 2) = d_i(10^k - 1)$$
 for $i \in \{1, \dots, 8\}$, and $d_9(10^k - 2) < d_9(10^k - 1)$.

This means that $\#\{d_i(10^k - 2) : 1 \le i \le 9\} = 2$.

To prove that $\#\{d_i\left(10^k-1\right)\} \leqslant 2$ we need an observation. Let $\overline{a_{k-1}a_{k-2}\dots a_0} \in \{1,\dots,10^k-1\}$ be the decimal expansion of an arbitrary number, possibly with leading zeroes. Then $\overline{a_{k-1}a_{k-2}\dots a_0}$ is divisible by n if and only if $\overline{a_{k-2}\dots a_0a_{k-1}}$ is divisible by n. Indeed, this follows from the fact that

$$10 \cdot \overline{a_{k-1} a_{k-2} \dots a_0} - \overline{a_{k-2} \dots a_0 a_{k-1}} = (10^k - 1) \cdot a_{k-1}$$

is divisible by n.

This observation shows that the set of multiples of n between 1 and 10^k-1 is invariant under simultaneous cyclic permutation of digits when numbers are written with leading zeroes. Hence, for each $i \in \{1, \ldots, 9\}$ the number $d_i \left(10^k-1\right)$ is k times larger than the number of k digit numbers which start from the digit i and are divisible by n. Since the latter number is either $\lfloor 10^{k-1}/n \rfloor$ or $1 + \lfloor 10^{k-1}/n \rfloor$, we conclude that $\#\{d_i \left(10^k-1\right)\} \le 2$.

Comment. More careful analysis shows that $\#\{d_i(10^k-1):1\leq i\leq 9\}=1$ if and only if $n\equiv 1\pmod{10}$, which is not the case for n=1829.

Let Q be a set of prime numbers, not necessarily finite. For a positive integer n consider its prime factorisation; define p(n) to be the sum of all the exponents and q(n) to be the sum of the exponents corresponding only to primes in Q. A positive integer n is called special if p(n) + p(n+1) and q(n) + q(n+1) are both even integers. Prove that there is a constant c > 0 independent of the set Q such that for any positive integer N > 100, the number of special integers in [1, N] is at least cN.

(For example, if $Q = \{3, 7\}$, then p(42) = 3, q(42) = 2, p(63) = 3, q(63) = 3, p(2022) = 3, q(2022) = 1.)

(Costa Rica)

Solution. Let us call two positive integers m, n friends if p(m) + p(n) and q(m) + q(n) are both even integers. We start by noting that the pairs (p(k), q(k)) modulo 2 can take at most 4 different values; thus, among any five different positive integers there are two which are friends.

In addition, both functions p and q satisfy f(ab) = f(a) + f(b) for any a, b. Therefore, if m and n are divisible by d, then both p and q satisfy the equality f(m) + f(n) = f(m/d) + f(n/d) + 2f(d). This implies that m, n are friends if and only if m/d, n/d are friends.

Let us call a set of integers $\{n_1, n_2, \ldots, n_5\}$ an interesting set if for any indexes i, j, the difference $d_{ij} = |n_i - n_j|$ divides both n_i and n_j . We claim that if elements of an interesting set are all positive, then we can obtain a special integer. Indeed, if we were able to construct such a set, then there would be a pair of integers $\{n_i, n_j\}$ which are friends, according to the first observation. Additionally, the second observation yields that the quotients $n_i/d_{ij}, n_j/d_{ij}$ form a pair of friends, which happen to be consecutive integers, thus giving a special integer as desired.

In order to construct a family of interesting sets, we can start by observing that the set $\{0, 6, 8, 9, 12\}$ is an interesting set. Using that $72 = 2^3 \cdot 3^2$ is the least common multiple of all pairwise differences in this set, we obtain a family of interesting sets by considering

$$\{72k, 72k + 6, 72k + 8, 72k + 9, 72k + 12\},\$$

for any $k \ge 1$. If we consider the quotients (of these numbers by the appropriate differences), then we obtain that the set

$$S_k = \{6k, 8k, 9k, 12k, 12k + 1, 18k + 2, 24k + 2, 24k + 3, 36k + 3, 72k + 8\},\$$


has at least one special integer. In particular, the interval [1, 100k] contains the sets $S_1, S_2, ..., S_k$, each of which has a special number. Any special number can be contained in at most ten sets S_k , from where we conclude that the number of special integers in [1, 100k] is at least k/10.

Finally, let N=100k+r, with $k \ge 1$ and $0 \le r < 100$, so that we have $N < 100(k+1) \le 200k$. Then the number of special integers in [1, N] is at least k/10 > N/2000, as we wanted to prove.

Comment 1. The statement is also true for $N \ge 15$ as at least one of the numbers 7, 14, 15 is special.

Comment 2. Another approach would be to note that if p(2n), p(2n+1), p(2n+2) all have the same parity then one of the numbers n, 2n, 2n+1 is special. Indeed, if q(n)+q(n+1) is even then n is special since $p(n)+p(n+1)\equiv p(2n)+p(2n+2)\equiv 0\pmod 2$. Otherwise, if q(n)+q(n+1) is odd, so is q(2n)+q(2n+2) which implies that exactly one of the numbers 2n, 2n+1 is special.

Unfortunately, it seems hard to show that the set of such n has positive density: see a recent paper https://arxiv.org/abs/1509.01545 for the proof that all eight patterns of the parities of p(n), p(n+1), p(n+2) appear for a positive proportion of positive integers.



N7. Let k be a positive integer and let S be a finite set of odd prime numbers. Prove that there is at most one way (modulo rotation and reflection) to place the elements of S around a circle such that the product of any two neighbors is of the form $x^2 + x + k$ for some positive integer x.

(U.S.A.)

Solution. Let us allow the value x = 0 as well; we prove the same statement under this more general constraint. Obviously that implies the statement with the original conditions.

Call a pair $\{p,q\}$ of primes with $p \neq q$ special if $pq = x^2 + x + k$ for some nonnegative integer x. The following claim is the key mechanism of the problem: Claim.

- (a) For every prime r, there are at most two primes less than r forming a special pair with r.
- (b) If such p and q exist, then $\{p, q\}$ is itself special.

We present two proofs of the claim.

Proof 1. We are interested in integers $1 \le x < r$ satisfying

$$x^2 + x + k \equiv 0 \pmod{r}.$$
 (1)

Since there are at most two residues modulo r that can satisfy that quadratic congruence, there are at most two possible values of x. That proves (a).

Now suppose there are primes p, q with p < q < r and nonnegative integers x, y such that

$$x^{2} + x + k = pr$$
$$y^{2} + y + k = qr.$$

From p < q < r we can see that $0 \le x < y \le r - 1$. The numbers x, y are the two solutions of (1); by Vieta's formulas, we should have $x + y \equiv -1 \pmod{r}$, so x + y = r - 1.

Letting K = 4k - 1, X = 2x + 1, and Y = 2y + 1, we obtain

$$4pr = X^2 + K,$$
$$4qr = Y^2 + K$$

with X + Y = 2r. Multiplying the two above equations,

$$16pqr^{2} = (X^{2} + K)(Y^{2} + K)$$

$$= (XY - K)^{2} + K(X + Y)^{2}$$

$$= (XY - K)^{2} + 4Kr^{2},$$

$$4pq = \left(\frac{XY - K}{2r}\right)^{2} + K.$$

In particular, the number $Z = \frac{XY - K}{2r}$ should be an integer, and so $4pq = Z^2 + K$. By parity, Z is odd, and thus

$$pq = z^2 + z + k$$
 where $z = \frac{Z - 1}{2}$,

so $\{p,q\}$ is special.

Proof 2. As before, we suppose that

$$x^{2} + x + k = pr$$
$$y^{2} + y + k = qr.$$

Subtracting, we have

$$(x + y + 1)(x - y) = r(p - q).$$

As before, we have x + y = r - 1, so x - y = p - q, and

$$x = \frac{1}{2}(r+p-q-1)$$
$$y = \frac{1}{2}(r+q-p-1).$$

Then,

$$\begin{split} k &= pr - x^2 - x = \frac{1}{4}(4pr - (r + p - q - 1)^2 - 2(r + p - q - 1)) \\ &= \frac{1}{4}(4pr - (r + p - q)^2 + 1) \\ &= \frac{1}{4}(2pq + 2pr + 2qr - p^2 - q^2 - r^2 + 1), \end{split}$$

which is symmetric in p, q, r, so

$$pq = z^2 + z + k$$
 where $z = \frac{1}{2}(p + q - r - 1)$,

and $\{p, q\}$ is special.

Now we settle the problem by induction on |S|, with $|S| \leq 3$ clear.

Suppose we have proven it for |S| = n and consider |S| = n + 1. Let r be the largest prime in S; the claim tells us that in any valid cycle of primes:

- the neighbors of r are uniquely determined, and
- \bullet removing r from the cycle results in a smaller valid cycle.

It follows that there is at most one valid cycle, completing the inductive step.

Comment. The statement is not as inapplicable as it might seem. For example, for k = 41, the following 385 primes form a valid cycle of primes:

Prove that $5^n - 3^n$ is not divisible by $2^n + 65$ for any positive integer n.

(Belgium)

Solution 1. Let n be a positive integer, and let $m = 2^n + 65$. For the sake of contradiction, suppose that $m \mid 5^n - 3^n$, so $5^n \equiv 3^n \pmod{m}$.

Notice that if n is even, then $3 \mid m$, but $3 \nmid 5^n - 3^n$, contradiction. So, from now on we assume that n is odd, n = 2k + 1. Obviously n = 1 is not possible, so $n \ge 3$. Notice that m is coprime to 2, 3 and 5.

Let m_1 be the smallest positive multiple of m that can be written in the form of either $|5a^2 - 3b^2|$ or $|a^2 - 15b^2|$ with some integers a and b.

Note that $5^n - 3^n = 5(5^k)^2 - 3(3^k)^2$ is a multiple of m, so the set of such multiples is non-empty, and therefore m_1 is well-defined.

I. First we show that $m_1 \leq 5m$. Consider the numbers

$$5^{k+1}x + 3^{k+1}y, \quad 0 \le x, y \le \sqrt{m}.$$

There are $\lfloor \sqrt{m} \rfloor + 1 > \sqrt{m}$ choices for x and y, so there are more than m possible pairs (x,y). Hence, two of these sums are congruent modulo m: $5^{k+1}x_1 + 3^{k+1}y_1 \equiv 5^{k+1}x_2 + 3^{k+1}y_2 \pmod{m}$.

Now choose $a = x_1 - x_2$ and $b = y_1 - y_2$; at least one of a, b is nonzero, and

$$5^{k+1}a + 3^{k+1}b \equiv 0 \pmod{m}, \quad |a|, |b| \le \sqrt{m}.$$

From

$$0 \equiv (5^{k+1}a)^2 - (3^{k+1}b)^2 = 5^{n+1}a^2 - 3^{n+1}b^2 \equiv 5 \cdot 3^n a^2 - 3^{n+1}b^2 = 3^n(5a^2 - 3b^2) \pmod{m}$$

we can see that $|5a^2-3b^2|$ is a multiple of m. Since at least one of a and b is nonzero, $5a^2 \neq 3b^2$. Hence, by the choice of a, b, we have $0 < |5a^2-3b^2| \leq \max(5a^2, 3b^2) \leq 5m$. That shows that $m_1 \leq 5m$.

- II. Next, we show that m_1 cannot be divisible by 2, 3 and 5. Since m_1 equals either $|5a^2 3b^2|$ or $|a^2 15b^2|$ with some integers a, b, we have six cases to check. In all six cases, we will get a contradiction by presenting another multiple of m, smaller than m_1 .
 - If $5 \mid m_1$ and $m_1 = |5a^2 3b^2|$, then $5 \mid b$ and $|a^2 15(\frac{b}{5})^2| = \frac{m_1}{5} < m_1$.
 - If $5 \mid m_1$ and $m_1 = |a^2 15b^2|$, then $5 \mid a$ and $\left| 5 \left(\frac{a}{5} \right)^2 3b^2 \right| = \frac{m_1}{5} < m_1$.
 - If $3 \mid m_1$ and $m_1 = |5a^2 3b^2|$, then $3 \mid a$ and $|b^2 15(\frac{a}{3})^2| = \frac{m_1}{3} < m_1$.
 - If $3 \mid m_1$ and $m_1 = |a^2 15b^2|$, then $3 \mid a$ and $|5b^2 3(\frac{a}{3})^2| = \frac{m_1}{3} < m_1$.
 - If $2 \mid m_1$ and $m_1 = |5a^2 3b^2|$, then $\left| \left(\frac{5a 3b}{2} \right)^2 15 \left(\frac{a b}{2} \right)^2 \right| = \frac{m_1}{2} < m_1$.
 - If $2 \mid m_1$ and $m_1 = |a^2 15b^2|$, then $\left| 5\left(\frac{a-3b}{2}\right)^2 3\left(\frac{a-5b}{2}\right)^2 \right| = \frac{m_1}{2} < m_1$.

(The last two expressions can be obtained from $(\sqrt{5}a + \sqrt{3}b)(\sqrt{5} - \sqrt{3}) = (5a - 3b) + \sqrt{15}(b - a)$ and $(a + \sqrt{15}b)(\sqrt{5} - \sqrt{3}) = \sqrt{5}(a - 3b) + \sqrt{3}(5b - a)$.)

In all six cases, we found that either $\frac{m_1}{2}$, $\frac{m_1}{3}$ or $\frac{m_1}{5}$ is of the form $|5x^2 - 3y^2|$ or $|x^2 - 15y^2|$. Since m is coprime to 2, 3 and 5, the presented number is a multiple of m, but this contradicts the minimality of m_1 .

III. The last remaining case is $m_1 = m$, so either $m = |5a^2 - 3b^2|$ or $m = |a^2 - 15b^2|$. We will get a contradiction by considering the two sides modulo 3, 4 and 5.

- $2^n + 65 = 5a^2 3b^2$ is not possible, because $2^n + 65 \equiv 1 \pmod{3}$, but $5a^2 3b^2 \not\equiv 1 \pmod{3}$.
- $2^n + 65 = 3b^2 5a^2$ is not possible, because $2^n + 65 \equiv 1 \pmod{4}$, but $3b^2 5a^2 \not\equiv 1 \pmod{4}$.
- $2^n + 65 = a^2 15b^2$ is not possible, because $2^n + 65 \equiv \pm 2 \pmod{5}$, but $a^2 15b^2 \not\equiv \pm 2 \pmod{5}$.
- $2^n + 65 = 15b^2 a^2$ is not possible, because $2^n + 65 \equiv 1 \pmod{4}$, but $15b^2 a^2 \not\equiv 1 \pmod{4}$.

We found a contradiction in all cases, that completes the solution.

Comment 1. Part I is a standard application of Thue's lemma:

Lemma (Thue). Suppose that m > 1 and c are integers, and X, Y are positive integers such that $X \leq m < XY$. Then there exist some integers x, y with |x| < X and 0 < y < Y, such that $x \equiv cy \pmod{m}$.

It is a well-known corollary that if c, d are coprime to m, the congruence $cx^2 \equiv dy^2 \pmod{m}$ has a solution such that x, y are coprime to m, and X, Y are positive integers such that XY > m, then $cx^2 \equiv dy^2 \pmod{m}$ has a solution such that at least one of x, y is nonzero, |x| < X and |y| < Y. In the solution we applied this corollary with c = 5, d = 3, $X = Y = \left| \sqrt{m} \right| + 1$.

Comment 2. In fact, we proved that a positive integer m with $m \equiv 13$ or 37 (mod 60) cannot divide any nonzero integer of the form $5a^2 - 3b^2$ or $a^2 - 15b^2$ with coprime integers a, b. In other words, if $m \equiv 13$ or 37 (mod 60), then 15 is not a quadratic residue modulo m. Using the tools of quadratic reciprocity, the solution can be significantly shortened.

Suppose that a and b are coprime. For every prime divisor p > 5 of $5a^2 - 3b^2$ or $a^2 - 15b^2$, we have

$$1 = \left(\frac{15}{p}\right) = \left(\frac{3}{p}\right) \left(\frac{5}{p}\right) = (-1)^{\frac{p-1}{2}} \left(\frac{p}{3}\right) \left(\frac{p}{5}\right),\tag{1}$$

where $\left(\frac{a}{p}\right)$ stands for the Legendre symbol. Considering the remainders of p when divided by 4, 3 and 5, (1) leads to

$$p \equiv \pm 1, \pm 7, \pm 11 \text{ or } \pm 17 \mod 60.$$

These remainders form a subgroup of the reduced remainders modulo 60. Since 13 and 37 are not elements in this subgroup, the number $m = 2^n + 65$ cannot be a product of such primes.

Instead of handling the prime divisors of m separately, we can use Jacobi symbols for further simplification, as shown in the next solution.

Solution 2. Suppose again that $5^n \equiv 3^n \pmod{m} = 2^n + 65$. Like in the first solution, we conclude that n must be odd, and $n \ge 3$, so $8 \mid 2^n$.

Using Jacobi symbols,

$$-1 = \left(\frac{2^n + 65}{5}\right) = \left(\frac{5}{2^n + 65}\right) = \left(\frac{5^n}{2^n + 65}\right) = \left(\frac{3^n}{2^n + 65}\right) = \left(\frac{3}{2^n + 65}\right) = \left(\frac{2^n + 65}{3}\right) = 1,$$

contradiction.
